TERMS AND CONDITIONS OF THE BONDS

The following, subject to completion and amendment, and save for the paragraphs in italics, is the text of the Terms and Conditions of the Bonds.

The U.S.\$50,000,000 2.875 per cent. Convertible Bonds due 2027 (the “**New Bonds**”) of HTA Group, Ltd (the “**Issuer**”) will be consolidated and form a single series with the U.S.\$250,000,000 2.875 per cent. Convertible Bonds due 2027 issued by the Issuer on 18 March 2021 (the “**Original Bonds**”), from and including 23 June 2021. The expression “**Bonds**” shall, unless otherwise indicated, mean the Original Bonds, the New Bonds and any Further Bonds (as defined below). The issue of the Original Bonds was authorised by a resolution of the board of directors of the Issuer passed on 8 March 2021, and the issue of the New Bonds was authorised by a resolution of the board of directors of the Issuer dated 4 May 2021. The giving of the senior unsecured guarantee by Helios Towers plc (the “**Parent Guarantor**”) in respect of the Original Bonds (the “**Parent Guarantee**”) was authorised by a resolution of the board of directors of the Parent Guarantor passed on 4 March 2021, and the Parent Guarantee in respect of the New Bonds was authorised by a resolution of the board of directors of the Parent Guarantor passed on 7 May 2021 and by resolutions of a committee of the board of directors of the Parent Guarantor passed on 15 June 2021 and 16 June 2021. The giving of senior unsecured guarantees by certain subsidiaries of the Parent Guarantor named in the Trust Deed and referred to below (the “**Initial Subsidiary Guarantors**”), on a joint and several basis, was authorised by the respective boards of directors of each Initial Subsidiary Guarantor. The Initial Subsidiary Guarantors together with any other entity for the time being appointed as a subsidiary guarantor under and as further described in the Trust Deed, but excluding any entity for the time being released as a guarantor, are referred to herein as the “**Subsidiary Guarantors**” and each, together with the Parent Guarantor, a “**Guarantor**”, and such senior unsecured guarantees given on a joint and several basis by the Subsidiary Guarantors are referred to as “**Subsidiary Guarantees**” and, together with the Parent Guarantee, the “**Guarantees**”.

On the Closing Date, the Bonds will be jointly and severally guaranteed by the Parent Guarantor and the following Initial Subsidiary Guarantors: Helios Towers, Ltd (Mauritius), HTA Holdings, Ltd. (Mauritius), HT Congo Brazzaville Holdco Limited (Mauritius), Helios Towers DRC SARL (DRC), HT Holdings Tanzania Ltd. (Mauritius), HT DRC Infraco SARL (DRC), HTT Infraco Limited (Tanzania), Towers NL Coöperatief (Netherlands), McTam International 1 B.V. (Netherlands), McRory Investment B.V. (Netherlands), Helios Towers Congo Brazzaville SASU (Congo Brazzaville), Helios Towers Ghana Limited (Ghana) and HTG Managed Services Limited (Ghana).

The Bonds are constituted by a trust deed dated 18 March 2021 as supplemented by a supplemental trust deed dated 23 June 2021 (together, the “**Trust Deed**”) between the Issuer, the Parent Guarantor, the Initial Subsidiary Guarantors and Citibank, N.A., London Branch (the “**Trustee**”, which expression shall include all persons for the time being appointed as the trustee or trustees under the Trust Deed) as trustee for the Bondholders (as defined below). The statements set out in these Terms and Conditions (the “**Conditions**”) are summaries of, and are subject to, the detailed provisions of the Trust Deed, which includes the form of the Bonds, and the Congo B Deed of Guarantee (as defined below). The Bondholders are entitled to the benefit of, are bound by, and are deemed to have notice of, all the provisions of the Trust Deed, the Congo B Deed of Guarantee, the Constitution of the Issuer (as defined below), the deed poll executed and delivered by the Parent Guarantor dated 18 March 2021 as supplemented by a supplemental deed poll dated 23 June 2021 (together, the “**Deed Poll**”) and those provisions applicable to them which are contained in the Paying, Transfer and Conversion Agency Agreement dated 18 March 2021 as supplemented by a supplemental paying, transfer and conversion agency agreement dated 23 June 2021 (together, the “**Agency Agreement**”) relating to the Bonds between the Issuer, the Parent Guarantor, the Trustee and Citibank, N.A., London Branch (the “**Principal Paying, Transfer and Conversion Agent**”, which expression shall include any successor as Principal Paying, Transfer and Conversion Agent under the Agency Agreement), the paying, transfer and conversion agents for the time being (such persons, together with the Principal Paying, Transfer and Conversion Agent, being referred to below as the “**Paying, Transfer and Conversion Agents**”, which expression shall include their successors as Paying, Transfer and Conversion Agents under the Agency Agreement) and Citigroup Global Markets Europe AG in its capacity as registrar in respect of the Bonds (the “**Registrar**”, which expression shall include any successor as registrar under the Agency Agreement).

The Issuer and the Parent Guarantor have also entered into a calculation agency agreement dated 18 March 2021 as supplemented by a supplemental calculation agency agreement dated 23 June 2021 (together, the “**Calculation Agency Agreement**”) with Conv-Ex Advisors Limited (the “**Calculation Agent**”, which expression shall include any successor as calculation agent under the Calculation Agency Agreement) whereby the Calculation Agent has been appointed to make certain calculations in relation to the Bonds.

Copies of the Trust Deed, the Congo B Deed of Guarantee, the Constitution of the Issuer, the Deed Poll, the Agency Agreement and the Calculation Agency Agreement are available for inspection during normal business hours and upon reasonable advanced notice at the specified offices of the Paying, Transfer and Conversion Agents or shall be provided electronically by the Principal Paying, Transfer and Conversion Agent upon request.

Capitalised terms used but not defined in these Conditions shall have the meanings attributed to them in the Trust Deed unless the context otherwise requires or unless otherwise stated.

1 Form, Denomination, Title, Status and Guarantees

(A) Form and Denomination

The Bonds are in registered form in principal amounts of U.S.\$200,000 each.

(B) Title

Title to the Bonds will pass by transfer and registration as described in Condition 4. The holder (as defined below) of any Bond will (except as otherwise required by law or as ordered by a court of competent jurisdiction) be treated as its absolute owner for all purposes (whether or not it is overdue and regardless of any notice of ownership, trust or any interest in it or its theft or loss (or that of the related certificate, as applicable) or anything written on it or the certificate representing it (other than a duly executed transfer thereof)) and no person will be liable for so treating the holder.

(C) Status of the Bonds

The Bonds constitute direct, unconditional, unsubordinated and (subject to Condition 2) unsecured obligations of the Issuer ranking *pari passu* and without any preference among themselves. The payment obligations of the Issuer under the Bonds shall, save for such exceptions as may be provided by mandatory provisions of legislation in the jurisdiction of the Issuer which are applicable to it and subject to Condition 2, at all times rank at least equally with all its other present and future unsecured and unsubordinated obligations.

(D) *Guarantee and Status*

(a) Guarantees

The payment of the principal and interest in respect of the Bonds and all other moneys from time to time payable by the Issuer under or pursuant to the Trust Deed and the Bonds and the due and punctual performance by the Issuer of all of the Issuer's other obligations in respect of the Bonds and under or pursuant to the Trust Deed has been unconditionally and irrevocably guaranteed by the Parent Guarantor in the Trust Deed.

The payment of the principal and interest in respect of the Bonds and all other moneys from time to time payable by the Issuer under or pursuant to the Trust Deed and the Bonds has been jointly and severally, unconditionally and irrevocably guaranteed by each of the Subsidiary Guarantors in the Trust Deed (or, in the case of Helios Towers Congo Brazzaville SASU, pursuant to a standalone deed of guarantee dated 18 March 2021 as supplemented by a supplemental standalone deed of guarantee dated 23 June 2021 (together, the "**Congo B Deed of Guarantee**")), subject to the provisions of Conditions 1(D)(c) and 1(D)(d).

(b) Status of the Guarantees

The obligations of each Guarantor under its Guarantee shall, save for such exceptions as may be provided by mandatory provisions of law in the jurisdiction of such Guarantor which are applicable to it and subject to Condition 2, at all times rank at least equally with all its other present and future unsecured and unsubordinated obligations.

(c) Limitation on Guarantees

The obligations of each Subsidiary Guarantor will be contractually limited under the applicable Subsidiary Guarantee contained in the Trust Deed (or, as the case may be, the Congo B Deed of Guarantee) to reflect certain limitations as may be applicable under law with respect to maintenance of share capital, corporate benefit, fraudulent conveyance, voidable transactions, exchange control laws and other legal restrictions applicable to the relevant Subsidiary Guarantor and their respective shareholders, directors and general partners.

(d) Release of a Subsidiary Guarantor

A Subsidiary Guarantor shall cease to be a Guarantor if the Issuer or the Parent Guarantor delivers notice to the Trustee signed by two Authorised Signatories of the Parent Guarantor certifying that:

- (i) no Event of Default or Potential Event of Default (as defined in the Trust Deed) is continuing or will result from the release of that Subsidiary Guarantor;
- (ii) no part of the indebtedness in respect of which that Subsidiary Guarantor is or was providing a guarantee is at that time due and payable but unpaid; and

- (iii) such Subsidiary Guarantor is not providing (or will cease to provide simultaneously with such release) a guarantee in respect of payment by the Issuer of indebtedness under the Existing Senior Notes or any Refinancing Notes and such Subsidiary Guarantor is not an issuer of any outstanding Refinancing Notes (whether or not guaranteed by the Issuer, the Parent Guarantor or any other Guarantor),

Upon the Trustee's receipt of such notice (which the Trustee shall rely on without liability to any person and without further enquiry), such Subsidiary Guarantor shall automatically and irrevocably be released and relieved of any obligation under its Guarantee, the Trust Deed and the Agency Agreement and the Trustee shall take (at the cost and expense of the Issuer and such Subsidiary Guarantor and without the consent or approval of the Bondholders) any necessary action required by the Issuer, the Parent Guarantor and/or such Subsidiary Guarantor to effect such release. Such notice must contain a certification to the effect provided in (i) to (iii) above.

A Subsidiary Guarantor that has been released pursuant to this Condition 1(D)(d), howsoever many times, may subsequently be required to provide a guarantee pursuant to the operation of Condition 1(D)(e).

(e) Additional Guarantors

If, at any time after 10 March 2021, any Subsidiary of the Parent Guarantor provides, or at the time it becomes a Subsidiary of the Parent Guarantor is providing, a guarantee in respect of payment by any of the Parent Guarantor, the Issuer or any Subsidiary Guarantor of indebtedness under the Existing Senior Notes or any Refinancing Notes, or the Issuer or Parent Guarantor provides such a guarantee of the indebtedness of a Subsidiary of the Parent Guarantor under the Existing Senior Notes or any Refinancing Notes or any Subsidiary Guarantor issues Refinancing Notes (whether or not guaranteed by the Parent Guarantor or any other Guarantor), the Parent Guarantor covenants that it shall, subject as provided below, procure that such Subsidiary shall on or around the date of the giving of such guarantee or the date on which it becomes a Subsidiary and is providing such a guarantee or, as the case may be, incurs such indebtedness, execute and deliver (i) a supplemental trust deed to the Trustee in form and substance satisfactory to the Trustee (acting reasonably), accompanied by a legal opinion from local counsel if an opinion has been so provided to the trustee in respect of the corresponding additional guarantee of such Subsidiary Guarantor under the Existing Senior Notes or any Refinancing Notes (but only if and to the extent such other legal opinion has been so provided) substantially in such form and with substantially similar qualifications as may be the case; and (ii) a supplemental agency agreement to the Trustee, the Registrar and the Paying, Transfer and Conversion Agents pursuant to which such Subsidiary shall guarantee the payment obligations of the Issuer in respect of the Bonds and the Trust Deed on the same terms *mutatis mutandis* as the Subsidiary Guarantees. Each other Guarantor has in the Trust Deed and the Agency Agreement confirmed that it has consented to any such entity becoming a Subsidiary Guarantor as aforesaid without any need for the Issuer or any such other Guarantor to execute any supplemental trust deed or supplemental agency agreement or otherwise.

Notwithstanding the foregoing, any such additional guarantee may be limited in amount to the extent such additional guarantee may reasonably be expected to give rise to or result in (a) any breach or violation of statutory limitations, corporate benefit, financial assistance, fraudulent preference, thin capitalisation rules, capital maintenance rules, guidance and coordination rules or the laws, rules or regulations (or analogous restriction) of any applicable jurisdiction, (b) any risk or liability for the officers, directors or shareholders of such Subsidiary (or in the case of a partnership, directors or shareholders of the partners of such partnership), or (c) any material cost,

expense, liability or obligation (including with respect to any taxes but excluding any obligation under such guarantee itself) that cannot be avoided by reasonable measures available to the Parent Guarantor (or which the Parent Guarantor can procure) other than reasonable out of pocket expenses (but in such a case the Parent Guarantor and the relevant Subsidiary will use all reasonable endeavours to overcome the relevant legal limit and will procure that the relevant Subsidiary undertakes all whitewash or similar procedures which are legally available to eliminate the relevant limit).

For so long as it is not permissible under applicable law or regulation for any Subsidiary to become a Subsidiary Guarantor as aforesaid, such Subsidiary shall not be required to execute and deliver such supplemental trust deed or such supplemental agency agreement as aforesaid or to become a Subsidiary Guarantor, but in such a case the Parent Guarantor shall, and shall procure that the relevant Subsidiary shall, use all reasonable endeavours to overcome the relevant legal prohibition precluding the giving of the guarantee and shall procure that the relevant Subsidiary undertakes all whitewash or similar procedures which are legally available to eliminate the relevant legal prohibition, and that such Subsidiary gives such guarantee at such time (and to the extent) that it thereafter becomes permissible).

The Trustee shall be entitled to rely without further enquiry and without liability to any person on a certificate signed by two Authorised Signatories of the Parent Guarantor detailing any of the matters referred to in the foregoing two paragraphs of this Condition 1(e).

(f) Guarantee Trigger Events

(i) **Ghana:** If at any time a Guarantee Introduction Trigger Event (Ghana) occurs, the Parent Guarantor shall, and shall procure that its Restricted Subsidiaries (as defined in Condition 2) shall, use reasonable efforts to ensure that the Trust Deed is introduced into Ghana and duly stamped under the Stamp Duty Act, 2005 (Act 689) of Ghana, and that applicable stamp duties are paid in respect of the Subsidiary Guarantees of HTG Managed Services Limited and Helios Towers Ghana Limited in an aggregate amount of not less than U.S.\$120 million as soon as practicable.

(ii) **Congo B:** The Parent Guarantor shall, and shall procure that its Restricted Subsidiaries shall, use reasonable efforts to ensure that the Subsidiary Guarantee of Helios Towers Congo Brazzaville SASU in an amount of not less than U.S.\$1.0 million becomes effective as soon as practicable following the Closing Date, including registration with the relevant tax authorities and applicable stamp duties paid thereon. If at any time a Guarantee Increase Trigger Event (Congo B) occurs, the Parent Guarantor shall, and shall procure that its Restricted Subsidiaries shall, use reasonable efforts to ensure that the Subsidiary Guarantee of Helios Towers Congo Brazzaville SASU in an amount of not less than U.S.\$36 million becomes effective as soon as practicable, including registration with the relevant tax authorities and applicable stamp duties paid thereon.

For these purposes, a “**Guarantee Introduction Trigger Event (Ghana)**” shall be deemed to occur if the Parent Guarantor is required to so introduce the Indenture (or equivalent notes guarantees) into Ghana in respect of the Existing Senior Notes or any Refinancing Notes; and a “**Guarantee Increase Trigger Event (Congo B)**” shall be deemed to occur if the Parent Guarantor is required to so effect an increase to the notes guarantee of Helios Towers Congo Brazzaville SASU in respect of the Existing Senior Notes or any Refinancing Notes.

As with the notes guarantee in respect of the Existing Senior Notes, the Trust Deed (which contains the Guarantees, including the Subsidiary Guarantees of the Ghanaian Guarantors) will

be executed outside of Ghana and will initially remain outside of Ghana. Subsidiary Guarantees of the Ghanaian Guarantors not initially submitted for stamping are required to be stamped in order to be enforceable in any civil proceeding before a Ghanaian court or arbitration tribunal. A document must be submitted for stamping within two months of its execution or, if executed outside Ghana, within two months of the document being first received in Ghana.

In line with the Existing Senior Notes, the initial amount of the Subsidiary Guarantee from the Congo Brazzaville Guarantor will be limited to U.S.\$1 million. This guaranteed amount will be raised to U.S.\$36 million only in the limited circumstances set out in this Condition 1(D)(f).

- (g) Notice of change of Guarantors

Notice of any release of a Subsidiary Guarantor or addition of a Guarantor pursuant to this Condition will be given to the Bondholders in accordance with Condition 17.

2 Negative Pledge

For so long as any Bond remains outstanding (as defined in the Trust Deed) and:

- (i) for so long as any Existing Senior Notes or Comparable Refinancing Notes that benefit from Existing Security are outstanding, neither the Issuer nor the Parent Guarantor will, and the Parent Guarantor will procure that none of its Relevant Subsidiaries will, create or permit to subsist any Security Interest other than Existing Security upon or with respect to the whole or any part of its present or future undertaking, assets or revenues (including any uncalled capital) to secure any Existing Senior Notes or any Refinancing Notes, or to secure any guarantee or indemnity in respect of any Existing Senior Notes or Refinancing Notes, without at the same time or prior thereto according to the Bonds the same security (including as to ranking) as is created to secure such Existing Senior Notes and/or Refinancing Notes, guarantee or indemnity or such other security or arrangement (whether or not including the giving of security) as either (i) the Trustee shall in its absolute discretion deem not materially less beneficial to the Bondholders or (ii) shall be approved by an Extraordinary Resolution (as defined in the Trust Deed) of the Bondholders; and
- (ii) for so long as no Existing Senior Notes or Comparable Refinancing Notes that benefit from Existing Security are outstanding, neither the Issuer nor the Parent Guarantor will, and the Parent Guarantor will procure that none of its Relevant Subsidiaries will, create or permit to subsist, any Security Interest other than a Permitted Security Interest upon or with respect to the whole or any part of its present or future undertaking, assets or revenues (including any uncalled capital) to secure any existing or future Relevant Indebtedness or to secure any guarantee or indemnity in respect of any Relevant Indebtedness, without at the same time or prior thereto according to the Bonds the same security (including as to ranking) as is created or subsisting to secure any such Relevant Indebtedness, guarantee or indemnity or such other security or other arrangement (whether or not including the giving of security) as either (i) the Trustee shall in its absolute discretion deem not materially less beneficial to the Bondholders or (ii) shall be approved by an Extraordinary Resolution of the Bondholders.

For the purposes of these Conditions:

“**Collateral**” means the rights of the Issuer under and related to (a) a certain unsecured term loan facility agreement dated 9 March 2017 between the Issuer (as lender) and HTT Infracore Limited (as borrower), as the same may be amended or refinanced from time to time; and (b) all other Tanzanian Intercompany Loans funded with a portion of the proceeds of the Existing Senior Notes, any Refinancing Notes and/or the Group’s *pari passu* debt facilities, and any loan repaying or refinancing such loan or any portion thereof.

“Comparable Refinancing Note” means a Refinancing Note which (i) allows the issuer thereof to designate subsidiaries as “restricted” or “unrestricted” on substantially the same basis as the Existing Senior Notes, (ii) contains financial covenants applicable to subsidiaries which have been so designated as restricted on substantially the same basis as the Existing Senior Notes and (iii) provides limitations on the ability to so designate subsidiaries as unrestricted which are substantially equivalent to those contained in the Existing Senior Notes.

“Existing Security” shall mean all Security Interests granted by the Issuer from time to time pursuant to certain security agreements, pledge agreements, collateral assignments and any other instrument or document in each case delivered pursuant to the Indenture, or any of the foregoing, as the same may be amended, supplemented or otherwise modified from time to time (together, the **“Proceeds Loan Pledge Documents”**) which create (and were intended to create) Security Interests in the Collateral.

“Indenture” means the indenture entered into and delivered by the Issuer on 18 June 2020 providing for the issuance of its 7.000% Senior Notes due 2025 (the **“Existing Senior Notes”**) and any additional notes provided for therein, ranking *pari passu* therewith and with the same terms as to status, redemption and otherwise.

“Non-recourse Project Financing” means any indebtedness incurred solely to finance a project or the restructuring or expansion of an existing project, in each case for the acquisition, construction, development or exploitation of any assets pursuant to which the person or persons to whom such indebtedness is or may be owned by the relevant borrower (i) expressly agrees or agree that the principal source of repayment of such funds will be the assets of, or the project and revenues generated by, such project (or by such restructuring or expansion thereof); and (ii) has or have no other recourse whatsoever to any member of the Group (or its assets and/or revenues) for the repayment of or a payment of such indebtedness.

“Non-recourse Securitisation Debt” means any indebtedness incurred in respect of or in connection with any securitisation or similar financing arrangement relating to assets owned by the Parent Guarantor or any of its Subsidiaries and where the recourse of the holders of such indebtedness against the Parent Guarantor and its Subsidiaries is limited solely to such assets or any income generated therefrom (other than representations, repurchase obligations or other obligations customary in securitisation transactions).

“Permitted Security Interest” means:

- (i) any Security Interest which is solely for the benefit of the Parent Guarantor or any other member of the Group;
- (ii) any Security Interest on assets acquired by a member of the Group after the Closing Date, provided that (i) any such Security Interest is in existence prior to, and has not been created at the instigation of the Parent Guarantor or relevant acquiring Group member in contemplation of, such acquisition; and (ii) the amount secured by the Security Interest does not exceed, at any time, the amount secured thereby as at the date of acquisition;
- (iii) any Security Interest on assets of any person which becomes a member of the Group after the Closing Date, provided that (x) any such Security Interest is in existence prior to, and has not been created at the instigation of the Parent Guarantor or relevant acquiring Group member in contemplation of, such person becoming a member of the Group; and (y) the amount secured by such Security Interest does not exceed, at any time, the amount secured thereby as at the date such person becomes a member of the Group;
- (iv) any Security Interest on cash, cash equivalents or other property arising in connection with the defeasance, discharge or redemption of indebtedness;
- (v) any Security Interest (a) on escrowed proceeds for the benefit of the related holders of debt securities or other indebtedness (or the underwriters or arrangers thereof); or (b) on cash set aside at the time of the

incurrence of any indebtedness or government securities purchased with such cash, in the case of each of sub-clause (a) and (b), to the extent such cash or government securities prefund the payment of interest on such indebtedness and are held in an escrow account or similar arrangement to be applied for such purpose;

- (vi) any Security Interest on any proceeds loan made by the Issuer or a Guarantor as issuer in connection with any future incurrence of indebtedness;
- (vii) any Security Interest securing Non-recourse Project Financing; and
- (viii) any Security Interest securing Non-recourse Securitisation Debt.

“Refinancing Notes” means any Relevant Indebtedness issued by or guaranteed by any of the Issuer, the Parent Guarantor or any Subsidiary Guarantor (including for this purpose any entity that was a guarantor in respect of the Existing Senior Notes and was released from such guarantee in anticipation of being a guarantor in respect of any indebtedness incurred to refinance, redeem or repurchase any Existing Senior Notes) in order to (directly or indirectly) refinance, redeem or repurchase any Existing Senior Notes.

“Relevant Indebtedness” means any present or future indebtedness (whether being principal, interest or other amounts) which (i) is in the form of or evidenced by notes, bonds, debentures, loan stock, certificates or other similar instruments, whether issued for cash or in whole or in part for a consideration other than cash, and which are or are intended by the issuer thereof to be capable of being, quoted, listed or dealt in or traded on any stock exchange, over-the-counter or other securities market; and (ii) is not denominated in ZAR and expressed to be governed by the laws of the Republic of South Africa.

“Relevant Subsidiary” means at any time:

- (i) for so long as any Existing Senior Notes or Comparable Refinancing Notes are outstanding, any Restricted Subsidiary (as defined therein) that is a Significant Subsidiary; or
- (ii) if no such Existing Senior Notes or Comparable Refinancing Notes remain outstanding, a Significant Subsidiary.

“Restricted Subsidiary” means any Subsidiary of the Parent Guarantor which at the time of determination is not designated as an Unrestricted Subsidiary pursuant to all of the Existing Senior Notes and/or Refinancing Notes for the time being outstanding.

“Security Interest” means any mortgage, charge, assignment by way of security, pledge, lien or other security interest securing any obligation of any person.

“Significant Subsidiary” means, at the date of determination, any Subsidiary of the Parent Guarantor that, together with its Subsidiaries, (i) for the most recently completed fiscal year, accounted for more than 10 per cent. of the consolidated revenues of the Parent Guarantor, or (ii) as of the end of the most recently completed fiscal year, was the owner of more than 10 per cent. of the consolidated Total Assets of the Parent Guarantor (after intercompany eliminations).

A certificate signed by two Authorised Signatories of the Parent Guarantor that in their opinion a Subsidiary is or is not, or was or was not, at any particular time or throughout any specified period a Significant Subsidiary shall, in the absence of manifest error, be conclusive and binding on the Trustee and the Bondholders and the Trustee shall be entitled to rely on such certificate without further enquiry and without liability to any person.

“Tanzanian Intercompany Loans” means loans lent from any of the Issuer, the Parent Guarantor or the Parent Guarantor’s other Subsidiaries outside Tanzania to Subsidiaries domiciled in Tanzania.

“**Total Assets**” means, with respect to any person as of any date, the total assets of such person, calculated on a consolidated basis in accordance with IFRS, excluding all inter-group items and investments in any Subsidiaries of such person of or by such person or any of its Subsidiaries, calculated to give *pro forma* effect to any purchases and sales that have occurred subsequent to such date.

3 Definitions

In these Conditions, unless otherwise provided:

“**Additional Ordinary Shares**” has the meaning provided in Condition 6(c).

“**Affiliate**” of any specified person means any other person directly or indirectly controlling or controlled by or under direct or indirect common control with such specified person. For purposes of this definition, "control", as used with respect to any person, means the possession, directly or indirectly, of the power to direct or cause the direction of the management or policies of such person, whether through the ownership of voting securities, by agreement or otherwise. For purposes of this definition, the terms "controlling", "controlled by" and "under common control with" have correlative meanings.

“**Articles of Association**” means the articles of association of the Parent Guarantor.

“**Authorised Signatory**” means any person who (a) is a director or the secretary of the Issuer or a Guarantor (as the case may be); or (b) has been notified by the Issuer or a Guarantor (as the case may be) in writing to the Trustee as being duly authorised to sign documents and to do other acts and things on behalf of the Issuer or such Guarantor (as the case may be) for the purposes of these Conditions and the Trust Deed.

“**Board of Directors**” means:

- (i) with respect to a corporation, the board of directors of the corporation or any committee thereof duly authorised to act on behalf of such board;
- (ii) with respect to a partnership, the board of directors of the general partner of the partnership or any committee thereof duly authorised to action on behalf of such board;
- (iii) with respect to a limited liability company, the managing member or members or any controlling committee of managing members thereof; and
- (iv) with respect to any other person, the board or committee of such person serving a similar function.

“**Bondholder**” and (in relation to a Bond) “**holder**” mean the person in whose name a Bond is registered in the Register (as defined in Condition 4(a)).

“**business day**” means, in relation to any place, a day (other than a Saturday or Sunday) on which commercial banks and foreign exchange markets are open for business in that place.

“**Capital Stock**” means:

- (i) with respect to any person that is a corporation, corporate stock;
- (ii) in the case of an association or business entity, any and all shares, interests, participations, rights or other equivalents (howsoever designated) of corporate stock;
- (iii) in the case of a partnership or limited liability company, partnership interests (whether general or limited), shares or membership interests; and
- (iv) any other interest or participation that confers on a person the right to receive a share of the profits and losses of, or distribution of assets of, the issuing person, but excluding from all of the foregoing any debt

securities convertible into Capital Stock, whether or not such debt securities include any right of participation with Capital Stock.

a “**Change of Control Event**” shall occur if (i) any person or persons (other than one or more Permitted Holders), acting in concert (as defined in the City Code on Takeovers and Mergers), acquire(s) or becomes entitled to control more than 50 per cent. of the votes that may ordinarily be cast on a poll at a general meeting of the Parent Guarantor (other than as a result of an Exempt Newco Scheme) or (ii) an offer is made, other than by one or more of the Permitted Holders or any person acting in concert with one or more of the Permitted Holders, to all (or as nearly as may be practicable all) Shareholders (or all (or as nearly as may be practicable all) such Shareholders other than the offeror and/or any associate (as defined in Section 988(1) of the Companies Act) of the offeror), to acquire all or a majority of the issued ordinary share capital of the Parent Guarantor or if any such person (save as aforesaid) proposes a Scheme of Arrangement with regard to such acquisition (other than an Exempt Newco Scheme) and (such offer or Scheme of Arrangement having become or been declared unconditional in all respects or having become effective) the right to cast more than 50 per cent. of the votes which may ordinarily be cast on a poll at a general meeting of the Parent Guarantor has or will become unconditionally vested in the offeror(s) or any such person and/or any associate (as defined in Section 988(1) of the Companies Act) of the offeror(s) or such person, as the case may be.

“**Change of Control Conversion Right Amendment**” has the meaning provided in Condition 11(b)(vii).

“**Closing Date**” means 18 March 2021.

References to the “Closing Date” in these Conditions are to the date on which the Original Bonds were issued. The closing date of the New Bonds is 23 June 2021.

“**Closing Price**” means, in respect of an Ordinary Share or any Security, Spin-Off Security, option, warrant or other right or asset, on any dealing day in respect thereof, the closing price on the Relevant Stock Exchange on such dealing day of an Ordinary Share or, as the case may be, such Security, Spin-Off Security, option, warrant or other right or asset published by or derived from Bloomberg page HP (or any successor ticker page) (setting Last Price, or any other successor setting and using values not adjusted for any event occurring after such dealing day; and for the avoidance of doubt, all values will be determined with all adjustment settings on the DPDF Page, or any successor or similar setting, switched off) in respect of such Ordinary Share, Security, Spin-Off Security, option, warrant or other right or asset (all as determined by the Calculation Agent) (and for the avoidance of doubt such Bloomberg page for the Ordinary Shares as at the Closing Date is HTWS LN Equity HP), if available or, in any other case, such other source (if any) as shall be determined in good faith to be appropriate by an Independent Adviser on such dealing day, provided that:

- (i) if on any such dealing day (for the purpose of this definition, the “**Original Date**”) such price is not available or cannot otherwise be determined as provided above, the Closing Price of an Ordinary Share, Security, Spin-Off Security, option, warrant, or other right or asset, as the case may be, in respect of such dealing day shall be the Closing Price, determined by the Calculation Agent as provided above, on the immediately preceding such dealing day in respect thereof on which the same can be so determined, provided however that if such immediately preceding dealing day falls prior to the fifth day before the Original Date, the Closing Price in respect of such dealing day shall be considered to be not capable of being determined pursuant to this *proviso* (i); and

and the Closing Price determined as aforesaid on or as at any dealing day shall, if not in the Relevant Currency, be translated into the Relevant Currency at the Prevailing Rate on such dealing day.

“**Code**” has the meaning provided in Condition 8(e).

“**Companies Act**” means the Companies Act 2006.

“**Constitution of the Issuer**” means the constitution of the Issuer dated 15 March 2021, as may be amended, supplemented, altered, varied or replaced from time to time.

“**Conversion Date**” has the meaning provided in Condition 6(h).

“**Conversion Notice**” has the meaning provided in Condition 6(h).

“**Conversion Period Commencement Date**” has the meaning provided in Condition 6(a).

“**Conversion Period**” has the meaning provided in Condition 6(a).

“**Conversion Right**” has the meaning provided in Condition 6(a).

“**Conversion Right Transfer**” has the meaning provided in Condition 6(n).

“**Current Market Price**” means, in respect of an Ordinary Share at a particular date, the arithmetic average of the daily Volume Weighted Average Price of an Ordinary Share on each of the five consecutive dealing days ending on the dealing day immediately preceding such date, as determined by the Calculation Agent; provided that:

“**dealing day**” means a day on which the Relevant Stock Exchange is open for business and on which Ordinary Shares, Securities, Spin-Off Securities, options, warrants or other rights or assets (as the case may be) may be dealt in (other than a day on which the Relevant Stock Exchange is scheduled to or does close prior to its regular weekday closing time), provided that, unless otherwise specified or the context otherwise requires, references to “dealing day” shall be a dealing day in respect of the Ordinary Shares.

“**Dividend**” means any dividend or distribution to Shareholders (including a Spin-Off) whether of cash, assets or other property, and however described and whether payable out of a share premium account, profits, retained earnings or any other capital or revenue reserve or account, and including a distribution or payment to Shareholders upon or in connection with a reduction of capital (and for these purposes a distribution of assets includes without limitation an issue of Ordinary Shares or other Securities credited as fully or partly paid up by way of capitalisation of profits or reserves), provided that:

- (a) where a Scrip Dividend is announced, then the Scrip Dividend in question shall be treated as a cash Dividend of an amount equal to the sum of:
 - (i) in respect of the portion (if any) of the Scrip Dividend (which may be the whole of the Scrip Dividend) for which a Shareholder or Shareholders may make an election, the value of the option with the highest value, with the value of each option being equal to the value of the relevant property comprising such option as at the Scrip Dividend Valuation Date provided that, in the case of an option comprising more than one type of property, the value of such option shall be equal to the sum of the values of each individual type of property comprising such option, determined as provided below; and
 - (ii) in respect of the portion (if any) of the Scrip Dividend (which may be the whole of the Scrip Dividend) which is not subject to such election, the value of such portion as determined as provided below,

and where the “**value**” of any property in or comprising of a Scrip Dividend shall be determined as follows:

- (x) in the case of Ordinary Shares comprised in such Scrip Dividend, the Current Market Price of such Ordinary Shares as at the Scrip Dividend Valuation Date;
- (y) in the case of cash comprising in such Scrip Dividend, the Fair Market Value of such cash as at the Scrip Dividend Valuation Date; and

- (z) in the case of any other property or assets comprised in such Scrip Dividend, the Fair Market Value of such other property or assets as at the Scrip Dividend Valuation Date;
- (b) any issue of Ordinary Shares falling within Condition 6(b)(i) or 6(b)(ii) shall be disregarded;
- (c) (A) a purchase or redemption or buy back of share capital of the Parent Guarantor by or on behalf of the Parent Guarantor or any of its Subsidiaries pursuant to any general authority for such purchases, redemptions or buy backs approved by a general meeting of Shareholders and in accordance with the price limits specified in Article 3 of Commission Delegated Regulation (EU) 2016/1052 (as it forms part of UK domestic law by virtue of the EUWA or any successor regulation providing a safe harbour for share buybacks by an issuer under applicable market abuse rules) shall not constitute a Dividend and (B) any other purchase or redemption or buy back of share capital of the Parent Guarantor by or on behalf of the Parent Guarantor or any of its Subsidiaries shall not constitute a Dividend unless, in the case of a purchase or redemption or buy back of Ordinary Shares by or on behalf of the Parent Guarantor or any of its Subsidiaries, the weighted average price per Ordinary Share (before expenses) on any day (a “**Specified Share Day**”) in respect of such purchases or redemptions or buy backs (translated, if not in the Relevant Currency, into the Relevant Currency at the Prevailing Rate on such day) exceeds by more than 5 per cent. the Current Market Price of an Ordinary Share:
 - (1) on the Specified Share Day; or
 - (2) where an announcement (excluding, for the avoidance of doubt for these purposes, any general authority for such purchases, redemptions or buy backs approved by a general meeting of Shareholders or any notice convening such a meeting of Shareholders) has been made of the intention to purchase, redeem or buy back Ordinary Shares at some future date at a specified price or where a tender offer is made, on the date of such announcement or, as the case may be, on the date of first public announcement of such tender offer (and regardless of whether or not a price per Ordinary Share, a minimum price per Ordinary Share or a price range or a formula for the determination thereof is or is not announced at such time),

in which case such purchase, redemption or buy back shall be deemed to constitute a Dividend in the Relevant Currency in an amount equal to the amount by which the aggregate price paid (before expenses) in respect of such Ordinary Shares purchased, redeemed or bought back by or on behalf of the Parent Guarantor or, as the case may be, any of its Subsidiaries (translated where appropriate into the Relevant Currency as provided above) exceeds the product of (i) 105 per cent. of such Current Market Price and (ii) the number of Ordinary Shares so purchased, redeemed or bought back;
- (d) if the Parent Guarantor or any of its Subsidiaries (or any person on its or their behalf) shall purchase, redeem or buy back any depositary or other receipts or certificates representing Ordinary Shares, the provisions of paragraph (c) above shall be applied in respect thereof in such manner and with such modifications (if any) as shall be determined in good faith by an Independent Adviser;
- (e) where a dividend or distribution is paid or made to Shareholders pursuant to any plan or arrangement implemented by the Parent Guarantor for the purpose of enabling Shareholders to elect, or which may require Shareholders, to receive dividends or distributions in respect of the Ordinary Shares held by them from a person other than (or in addition to) the Parent Guarantor, such dividend or distribution shall for the purposes of these Conditions be treated as a dividend or distribution made or paid to Shareholders by the Parent Guarantor, and the foregoing provisions of this definition and the provisions of these Conditions shall be construed accordingly;

- (f) where a Dividend in cash is declared or announced in the Relevant Currency (or, in the case of a Scrip Dividend, an amount in cash is or may be paid in the Relevant Currency whether at the option of Shareholders or otherwise), it shall be treated as a Dividend in cash (or, in the case of a Scrip Dividend, an amount in cash) in such Relevant Currency, and in any other case it shall be treated as a Dividend in cash (or, in the case of a Scrip Dividend an amount in cash) in the currency in which it is payable by the Parent Guarantor; and
- (g) a dividend or distribution that is a Spin-Off shall be deemed to be a Dividend paid or made by the Parent Guarantor,

and any such determination shall be made in good faith by the Calculation Agent or, where specifically provided, an Independent Adviser and, in either such case, on a gross basis and disregarding any withholding or deduction required to be made for or on account of tax, and disregarding any associated tax credit.

“equity share capital” means, in relation to any entity, its issued share capital excluding any part of that capital which, neither as respects dividends nor as respects capital, carries any right to participate beyond a specific amount in a distribution.

“EUWA” means the European Union (Withdrawal) Act 2018.

“Event of Default” means an event described in Condition 10 which, if required by such Condition, the Trustee has certified in its opinion is or is likely to be materially prejudicial to the interests of the Bondholders.

“Ex-Date” means, in relation to any Dividend (including without limitation any Spin-Off), capitalisation, redesignation, reclassification, sub-division, consolidation, issue, grant, offer or other entitlement, unless otherwise defined herein, the first dealing day on which the Ordinary Shares are traded ex- the relevant Dividend, capitalisation, redesignation, reclassification, sub-division, consolidation, issue, grant, offer or other entitlement on the Relevant Stock Exchange (or, in the case of a Dividend which is a purchase, redemption or buy back of Ordinary Shares (or, as the case may be, any depositary or other receipts or certificates representing Ordinary Shares) pursuant to paragraph (c) (or, as the case may be, paragraph (d)) of the definition of “Dividend”, the date on which such purchase, redemption or buy back is made), and provided that, for the avoidance of doubt, the Ex-Date in respect of a Scrip Dividend shall be deemed to be the Ex-Date in respect of the relevant Dividend or capitalisation as referred to in the definition of “Scrip Dividend”.

“Exempt Newco Scheme” means a Newco Scheme where, immediately after completion of the relevant Scheme of Arrangement, the ordinary shares or units or equivalent of Newco (or depositary or other receipts or certificates representing ordinary shares or units or equivalent of Newco) are (1) admitted to trading on the Relevant Stock Exchange or a Regulated Market or (2) admitted to listing on such other regulated, regularly operating, recognised stock exchange as the Parent Guarantor or Newco may determine.

References to any issue or offer or grant to Shareholders or Existing Shareholders “**as a class**” or “**by way of rights**” shall be taken to be references to an issue or offer or grant to all or substantially all Shareholders or Existing Shareholders, as the case may be, other than Shareholders or Existing Shareholders, as the case may be, to whom, by reason of the laws of any territory or requirements of any recognised regulatory body or any other stock exchange or securities market in any territory or in connection with fractional entitlements, it is determined not to make such issue or offer or grant.

In making any calculation or determination of Closing Price, Current Market Price or Volume Weighted Average Price, such adjustments (if any) shall be made in good faith and as the Calculation Agent or an Independent Adviser considers appropriate to reflect any consolidation or sub-division of the Ordinary Shares or any issue of Ordinary Shares by way of capitalisation of profits or reserves, or any like or similar event.

For the purposes of this Condition 3, Condition 6(b), Condition 6(e) and Condition 11 only, (i) references to the “**issue**” of Ordinary Shares or Ordinary Shares being “**issued**” shall include the issue or transfer and delivery of Ordinary Shares, whether newly issued and allotted or previously existing or held by or on behalf of the Parent Guarantor or any of its Subsidiaries (although, for the avoidance of doubt, only newly issued Ordinary Shares will be deliverable upon exchange of Preference Shares); and (ii) Ordinary Shares held by or on behalf of the Parent Guarantor or any of its Subsidiaries (and which, in the case of Condition 6(b)(iv), do not rank for the relevant right or other entitlement) shall not be considered as or treated as “**in issue**” or “**issued**”, or entitled to receive the relevant Dividend, right or other entitlement.

4 Registration and Transfer of Bonds

(a) Registration

The Issuer will cause a register (the “**Register**”) to be kept at the specified office of the Registrar outside the United Kingdom on which will be entered the names and addresses of the holders of the Bonds and the particulars of the Bonds held by them and of all transfers, redemptions and conversions of Bonds.

(b) Transfer

Bonds may, subject to the terms of the Agency Agreement and to Conditions 4(c) and 4(d), be transferred by lodging the relevant Bond (with the form of application for transfer in respect thereof duly executed and duly stamped where applicable) at the specified office of the Registrar or any Paying, Transfer and Conversion Agent.

No transfer of a Bond will be valid unless and until entered on the Register. A Bond may be registered only in the name of, and transferred only to, a named person (or persons, not exceeding four in number).

The Registrar will within seven business days, in the place of the specified office of the Registrar, of any duly made application for the transfer of a Bond, register the relevant transfer and deliver a new Bond to the transferee at the specified office of the Registrar or (at the risk and, if mailed at the request of the transferee or, as the case may be, the transferor otherwise than by ordinary mail, at the expense of the transferee or, as the case may be, the transferor) mail the Bond by uninsured mail to such address as the transferee or, as the case may be, the transferor may request.

(c) *Formalities Free of Charge*

Such transfer will be effected without charge subject to (i) the person making such application for transfer paying or procuring the payment of any taxes, duties and other governmental charges in connection therewith, (ii) the Registrar being satisfied with the documents of title and/or identity of the person making the application and (iii) such reasonable regulations as the Issuer may from time to time agree with the Registrar and the Trustee (and as initially set out in the Agency Agreement).

(d) *Closed Periods*

Neither the Issuer nor the Registrar will be required to register the transfer of any Bond (or part thereof) (i) during the period of 15 days ending on and including the day immediately prior to the Final Maturity Date or any earlier date fixed for redemption of the Bonds pursuant to Condition 7(b) or 7(c); (ii) in respect of which a Conversion Notice has been delivered in accordance with Condition 6(h); (iii) in respect of which a Bondholder has exercised its right to require redemption pursuant to Condition 7(e); or (iv) during the period of 15 days ending on (and including) any Record Date in respect of any payment of interest on the Bonds.

5 Interest

(a) *Interest Rate*

The Bonds bear interest from (and including) the Closing Date at the rate of 2.875 per cent. per annum calculated by reference to the principal amount thereof and payable semi-annually in arrear on 18 September and 18 March in each year (each an “**Interest Payment Date**”), with the first Interest Payment Date falling on 18 September 2021 (the “**First Interest Payment Date**”).

If interest is required to be calculated for a period of less than a complete Interest Period (as defined below), the relevant day-count fraction will be determined on the basis of a 360-day year consisting of 12 months of 30 days each and, in the case of an incomplete month, the number of days elapsed.

“**Interest Period**” means the period beginning on (and including) the Closing Date and ending on (but excluding) the first Interest Payment Date and each successive period beginning on (and including) an Interest Payment Date and ending on (but excluding) the next succeeding Interest Payment Date.

(b) *Accrual of Interest*

Each Bond will cease to bear interest (i) where the Conversion Right shall have been exercised by a Bondholder, from the Interest Payment Date immediately preceding the relevant Conversion Date or, if none, the Closing Date (subject in any such case as provided in Condition 6(k)) or (ii) where such Bond is redeemed or repaid pursuant to Condition 8 or Condition 10, from the due date for redemption or repayment thereof unless, upon surrender thereof, payment of principal is improperly withheld or refused, in which event interest will continue to accrue at the rate specified in Condition 5(a) (both before and after judgment) up to, but excluding, the Relevant Date.

6 Conversion of Bonds

(a) *Conversion Period and Exchange Price*

Subject to and as provided in these Conditions, each Bond shall entitle the holder to convert each U.S.\$200,000 principal amount of such Bond into one fully paid up Preference Share, with each such Preference Share being issued and allotted at a price equal to the Paid-Up Value (a “**Conversion Right**”).

Upon exercise of Conversion Rights by a Bondholder, the Issuer will issue the relevant number of Preference Shares to the relevant Bondholder on and as at the relevant Conversion Date.

All Preference Shares issued on conversion of any Bonds shall (without any further action being required to be taken by, and without any cost or expense to, the relevant Bondholder, the Principal Paying, Transfer and Conversion Agent or the Trustee) automatically be deemed to be transferred on and as at the relevant Conversion Date from the relevant Bondholder to the Parent Guarantor and in consideration therefor the Parent Guarantor shall issue to the relevant Bondholder the relevant number of Reference Shares in respect of such exercise of Conversion Rights (subject to Condition 6(c)).

The initial Exchange Price is U.S.\$2.9312. The Exchange Price is subject to adjustment in the circumstances described in Condition 6(b). The expression “**Exchange Price**” shall be construed accordingly.

Subject to and as provided in these Conditions, the Conversion Right in respect of a Bond may be exercised, at the option of the holder thereof, at any time subject to any applicable fiscal or other laws or regulations and as hereinafter provided) from (and including) 28 April 2021 (the “**Conversion Period Commencement Date**”) to (and including) the date falling seven London business days prior to the Final Maturity Date or, if such Bond is to be redeemed pursuant to Condition 7(b) or 7(c) prior to the Final Maturity Date, then up to (and including) the date falling seven London business days before the date fixed for redemption thereof pursuant to Condition 7(b) or 7(c), unless there shall be a default in making payment in respect of such Bond on any such date fixed for redemption, in which event the Conversion Right shall extend up to (and including) the date on which the full amount of such payment becomes available for payment and notice of such availability has been given to Bondholders or, if earlier, the Final Maturity Date; provided that, in each case, if such final date for the exercise of Conversion Rights is not a London business day, then the period for exercise of Conversion Rights by Bondholders shall end on (and include) the immediately preceding London business day.

Notwithstanding the foregoing, if a Relevant Event occurs, the Conversion Right may also be exercised at any time during the Relevant Event Period, notwithstanding that all or part of such period falls prior to the Conversion Period Commencement Date, in which case Bondholders exercising the Conversion Right prior to the Conversion Period Commencement Date shall, as a pre-condition to receiving Ordinary Shares upon exchange of the Preference Shares, be required to certify in the Conversion Notice, among other things, that it or, if it is a broker-dealer acting on behalf of a customer, such customer:

- (i) will, on conversion, become the beneficial owner of the Ordinary Shares issued upon exchange of the Preference Shares; and
- (ii) is located outside the United States (within the meaning of Regulation S under the U.S. Securities Act of 1933, as amended).

Conversion Rights may not be exercised (i) following the giving of notice by the Trustee pursuant to Condition 10 that the Bonds are immediately due and payable or (ii) in respect of a Bond in respect of which the relevant Bondholder has exercised its right to require the Issuer to redeem that Bond pursuant to Condition 7(e).

Save in the circumstances described in Condition 6(k) in respect of any notice given by the Issuer pursuant to Condition 7(b) or 7(c), Conversion Rights may not be exercised by a Bondholder in circumstances where the relevant Conversion Date would fall during the period commencing on the Record Date in respect of any payment of interest on the Bonds and ending on the relevant Interest Payment Date (both days inclusive).

The period during which Conversion Rights may (subject as provided below) be exercised by a Bondholder is referred to as the “**Conversion Period**”.

The Parent Guarantor will procure that Ordinary Shares to be issued on exercise of Conversion Rights will be issued to the holder of the Bonds completing the relevant Conversion Notice or their nominee as specified in the relevant Conversion Notice in accordance with the provisions of Conditions 6(h) and 6(i). Such Ordinary Shares will be deemed to be issued and delivered as of the relevant Conversion Date. Any Additional Ordinary Shares to be issued pursuant to Condition 6(c) will be deemed to be issued and delivered as of the relevant Reference Date.

Each of the Issuer and the Parent Guarantor shall (at its own expense) do all such things and make all such entries in the Issuer’s and the Parent Guarantor’s respective registers of members and execute all such documents, whether at the request of the Trustee, on behalf of the relevant Bondholders or otherwise (including the execution of such instruments of transfer on behalf of the relevant Bondholders) as may be necessary to effect such exchange of Preference Shares.

Conversion Rights are not exercisable in respect of any specific Preference Shares or Ordinary Shares and no Preference Shares, Ordinary Shares have been or will be charged, placed in custody or otherwise set aside to secure or satisfy the obligations of the Issuer and the Parent Guarantor in respect of the delivery of Preference Shares or Ordinary Shares.

Upon the issue of the Preference Shares on conversion of any Bonds and the registration and transfer of such Preference Shares to the Parent Guarantor as provided in these Conditions and, where applicable, the payment of any interest pursuant to Condition 6(k), the Issuer shall be released from and shall have no further liability in respect of such Bonds, including in respect of the delivery of Ordinary Shares.

Fractions of Ordinary Shares will not be issued on exercise of Conversion Rights or pursuant to Condition 6(c) and no cash payment or other adjustment will be made in lieu thereof. However, if the Conversion Right in respect of more than one Bond is exercised at any one time such that Ordinary Shares to be issued in respect of such exercise are to be registered in the same name, the number of such Ordinary Shares to be issued in respect thereof shall, in accordance with the definition of “Reference Shares”, be calculated by the Calculation Agent on the basis of the aggregate Paid-up Value of the Preference Shares issued on such conversion and which are to be exchanged for Ordinary Shares, and rounded down to the nearest whole number of Ordinary Shares.

(b) *Adjustment of Exchange Price*

Upon the occurrence of any of the events described below, the Exchange Price shall be adjusted by the Calculation Agent as follows:

(i) *Consolidation, reclassification, redesignation or subdivision*

If and whenever there shall be a consolidation, reclassification, redesignation or subdivision affecting the number of Ordinary Shares in issue, the Exchange Price shall be adjusted by multiplying the Exchange Price in force immediately prior to the Effective Date by the following fraction:

$$\frac{A}{B}$$

where:

- A is the aggregate number of Ordinary Shares in issue immediately before such consolidation, reclassification, redesignation or subdivision, as the case may be; and
- B is the aggregate number of Ordinary Shares in issue immediately after, and as a result of, such consolidation, reclassification, redesignation or subdivision, as the case may be.

Such adjustment shall become effective on the Effective Date.

“**Effective Date**” means, in respect of this paragraph (b)(i), the date on which the consolidation, reclassification, redesignation or sub-division, as the case may be, takes effect.

(ii) *Capitalisation of profits or reserves*

If and whenever the Parent Guarantor shall issue any Ordinary Shares credited as fully paid to Shareholders by way of capitalisation of profits or reserves, including any share premium account or capital redemption reserve (other than an issue of Ordinary Shares constituting a Scrip Dividend) the Exchange Price shall be adjusted by multiplying the Exchange Price in force immediately prior to the Effective Date by the following fraction:

$$\frac{A}{B}$$

where:

- A is the aggregate number of Ordinary Shares in issue immediately before such issue; and
- B is the aggregate number of Ordinary Shares in issue immediately after such issue.

Such adjustment shall become effective on the Effective Date.

“**Effective Date**” means, in respect of this paragraph (b)(ii), the date of issue of such Ordinary Shares.

(iii) *Dividends*

- (A) If and whenever the Parent Guarantor shall declare, announce, make or pay any Dividend to the Shareholders, the Exchange Price shall be adjusted by multiplying the Exchange Price in force immediately prior to the Effective Date by the following fraction:

$$\frac{A - B}{A}$$

where:

- A is the Current Market Price of one Ordinary Share on the Ex-Date in respect of such Dividend; and
- B is the portion of the Fair Market Value of the aggregate Dividend attributable to one Ordinary Share, with such portion being determined by dividing the Fair Market Value of the aggregate Dividend by the number of Ordinary Shares entitled to receive the relevant Dividend (or, in the case of a purchase, redemption or buy back of Ordinary Shares or any depositary or other receipts or certificates representing Ordinary Shares by or on behalf of the Parent Guarantor or any Subsidiary of the Parent Guarantor, by

the number of Ordinary Shares in issue immediately following such purchase, redemption or buy back, and treating as not being in issue any Ordinary Shares, or any Ordinary Shares represented by depositary or other receipts or certificates, purchased, redeemed or bought back).

Such adjustment shall become effective on the Effective Date.

“**Effective Date**” means, in respect of this paragraph (b)(iii)(A), the later of (i) the Ex-Date in respect of such Dividend and (ii) the first date upon which the Fair Market Value of the relevant Dividend is capable of being determined as provided herein.

(B) For the purposes of the above, Fair Market Value shall (subject as provided in paragraph (a) of the definition of “Dividend” and in the definition of “Fair Market Value”) be determined as at the Ex-Date in respect of the relevant Dividend.

(iv) *Rights issues*

If and whenever the Parent Guarantor or any Subsidiary of the Parent Guarantor or (at the direction or request or pursuant to any arrangements with the Parent Guarantor or any Subsidiary of the Parent Guarantor) any other company, person or entity shall issue any Ordinary Shares to Shareholders as a class by way of rights, or shall issue or grant to Shareholders as a class by way of rights, any options, warrants or other rights to subscribe for or purchase or otherwise acquire any Ordinary Shares, or any Securities which by their terms of issue carry (directly or indirectly) rights of conversion into, or exchange or subscription for, or the right to otherwise acquire, any Ordinary Shares (or shall grant any such rights in respect of existing Securities so issued), in each case at a consideration receivable per Ordinary Share (based, where appropriate, on such number of Ordinary Shares as is determined pursuant to the definition of “C” and the *proviso* below) which is less than 95 per cent. of the Current Market Price per Ordinary Share on the Ex-Date in respect of the relevant issue or grant, the Exchange Price shall be adjusted by multiplying the Exchange Price in force immediately prior to the Effective Date by the following fraction:

$$\frac{A+B}{A+C}$$

where:

- A is the number of Ordinary Shares in issue on such Ex-Date;
- B is the number of Ordinary Shares which the aggregate consideration (if any) receivable for the Ordinary Shares issued by way of rights, or for the Securities issued by way of rights and upon exercise of rights of conversion into, or exchange or subscription for, or the right to otherwise acquire, Ordinary Shares, or for the options or warrants or other rights issued by way of rights and for the total number of Ordinary Shares deliverable on the exercise thereof, would purchase at such Current Market Price per Ordinary Share; and
- C is the number of Ordinary Shares to be issued or, as the case may be, the maximum number of Ordinary Shares which may be issued upon exercise of such options, warrants or rights calculated as at the date of issue of such options, warrants or rights or upon conversion or exchange or exercise of rights of subscription or purchase or other rights of acquisition in respect thereof at the initial conversion, exchange, subscription, purchase or acquisition price or rate;

provided that if on such Ex-Date such number of Ordinary Shares is to be determined by reference to the application of a formula or other variable feature or the occurrence of any event at some subsequent time, then for the purposes of this paragraph (b)(iv), “C” shall be determined by the application of such formula or variable feature or as if the relevant event occurs or had occurred as at such Ex-Date and as if such conversion, exchange, subscription, purchase or acquisition had taken place on such Ex-Date.

Such adjustment shall become effective on the Effective Date.

“**Effective Date**” means, in respect of this paragraph (b)(iv), the later of (i) the Ex-Date in respect of the relevant issue or grant and (ii) the first date upon which the adjusted Exchange Price is capable of being determined in accordance with this paragraph (b)(iv).

(v) *Issue of Securities to Shareholders*

If and whenever the Parent Guarantor or any Subsidiary of the Parent Guarantor or (at the direction or request or pursuant to any arrangements with the Parent Guarantor or any Subsidiary of the Parent Guarantor) any other company, person or entity shall (other than in the circumstances the subject of paragraph (b)(iv) and other than constituting a Scrip Dividend) issue any Securities to Shareholders as a class by way of rights or grant to Shareholders as a class by way of rights any options, warrants or other rights to subscribe for or purchase or otherwise acquire any Securities, the Exchange Price shall be adjusted by multiplying the Exchange Price in force immediately prior to the Effective Date by the following fraction:

$$\frac{A - B}{A}$$

where:

A is the Current Market Price of one Ordinary Share on the Ex-Date in respect of the relevant issue or grant; and

B is the Fair Market Value on such Ex-Date of the portion of the rights attributable to one Ordinary Share.

Such adjustment shall become effective on the Effective Date.

“**Effective Date**” means, in respect of this paragraph (b)(v), the later of (i) the Ex-Date in respect of the relevant issue or grant and (ii) the first date upon which the adjusted Exchange Price is capable of being determined in accordance with this paragraph (b)(v).

(vi) *Issue of Ordinary Shares at below Current Market Price*

If and whenever the Parent Guarantor shall issue (otherwise than as mentioned in paragraph (b)(iv) above) wholly for cash or for no consideration any Ordinary Shares (other than Ordinary Shares issued on exchange for the Preference Shares in respect of a conversion of the Bonds (which term shall for this purpose include any Further Bonds) or on the exercise of any rights of conversion into, or exchange or subscription for or purchase of, or rights to otherwise acquire, Ordinary Shares and other than constituting a Scrip Dividend) or if and whenever the Parent Guarantor or any Subsidiary of the Parent Guarantor or (at the direction or request or pursuant to any arrangements with the Parent Guarantor or any Subsidiary of the Parent Guarantor) any other company, person or entity shall issue or grant (otherwise than as mentioned in paragraph (b)(iv) above) wholly for cash or for no consideration any options, warrants or other rights to subscribe for or purchase or otherwise acquire any Ordinary Shares (other than the Bonds, which term shall

for this purpose include any Further Bonds), in each case at consideration receivable per Ordinary Share (based, where appropriate, on such number of Ordinary Shares as is determined pursuant to the definition of “C” and the *proviso* below) which is less than 95 per cent. of the Current Market Price per Ordinary Share on the date of first public announcement of the terms of such issue or grant, the Exchange Price shall be adjusted by multiplying the Exchange Price in force immediately prior to the Effective Date by the following fraction:

$$\frac{A+B}{A+C}$$

where:

- A is the number of Ordinary Shares in issue immediately before the date of first public announcement of the terms of such issue of Ordinary Shares or issue or grant of options, warrants or other rights as provided above;
- B is the number of Ordinary Shares which the aggregate consideration (if any) receivable for the issue of such Ordinary Shares or, as the case may be, for the Ordinary Shares to be issued or otherwise made available upon the exercise of any such options, warrants or rights, would purchase at such Current Market Price per Ordinary Share; and
- C is the number of Ordinary Shares to be issued pursuant to such issue of such Ordinary Shares or, as the case may be, the maximum number of Ordinary Shares which may be issued upon exercise of such options, warrants or rights calculated as at the date of issue of such options, warrants or rights;

provided that if on the date of first public announcement of the terms of such issue or grant (as used in this paragraph (b)(vi), the “**Specified Date**”) such number of Ordinary Shares is to be determined by reference to the application of a formula or other variable feature or the occurrence of any event at some subsequent time, then for the purposes of this paragraph (b)(vi), “C” shall be determined by the application of such formula or variable feature or as if the relevant event occurs or had occurred as at the Specified Date and as if such conversion, exchange, subscription, purchase, acquisition had taken place on the Specified Date.

Such adjustment shall become effective on the Effective Date.

“**Effective Date**” means, in respect of this paragraph (b)(vi), the later of (i) the date of issue of such Ordinary Shares or, as the case may be, the issue or grant of such options, warrants or rights and (ii) the first date upon which the adjusted Exchange Price is capable of being determined in accordance with this paragraph (b)(vi).

(vii) *Other issues*

If and whenever the Parent Guarantor or any Subsidiary of the Parent Guarantor or (at the direction or request of or pursuant to any arrangements with the Parent Guarantor or any Subsidiary of the Parent Guarantor) any other company, person or entity shall (otherwise than as mentioned in paragraphs (b)(iv), (b)(v) or (b)(vi) above) issue wholly for cash or for no consideration any Securities (other than the Bonds which term shall for this purpose exclude any Further Bonds and other than constituting a Scrip Dividend) which by their terms of issue carry (directly or indirectly) rights of conversion into, or exchange or subscription for, purchase of, or rights to otherwise acquire, Ordinary Shares (or shall grant any such rights in respect of existing Securities so issued) or Securities which by their terms might be reclassified or redesignated as Ordinary Shares, and the consideration per Ordinary Share (based, where appropriate, on such

number of Ordinary Shares as is determined pursuant to the definition of “C” and the *proviso* below) receivable upon conversion, exchange, subscription, purchase, acquisition, reclassification or redesignation is less than 95 per cent. of the Current Market Price per Ordinary Share on the date of first public announcement of the terms of the issue of such Securities (or the terms of such grant), the Exchange Price shall be adjusted by multiplying the Exchange Price in force immediately prior to the Effective Date by the following fraction:

$$\frac{A+B}{A+C}$$

where:

- A is the number of Ordinary Shares in issue immediately before the date of first public announcement of the terms of the issue of such Securities (or the terms of such grant);
- B is the number of Ordinary Shares which the aggregate consideration (if any) receivable for the Ordinary Shares to be issued or otherwise made available upon conversion or exchange or upon exercise of the right of subscription, purchase or acquisition attached to such Securities or, as the case may be, for the Ordinary Shares to be issued or to arise from any such reclassification or redesignation would purchase at such Current Market Price per Ordinary Share; and
- C is the maximum number of Ordinary Shares to be issued or otherwise made available upon conversion or exchange of such Securities or upon the exercise of such right of subscription, purchase or acquisition attached thereto at the initial conversion, exchange, subscription, purchase or acquisition price or rate or, as the case may be, the maximum number of Ordinary Shares which may be issued or arise from any such reclassification or redesignation;

provided that if on the date of first public announcement of the terms of the issue of such Securities (or the terms of such grant) (as used in this paragraph, the “**Specified Date**”) such number of Ordinary Shares is to be determined by reference to the application of a formula or other variable feature or the occurrence of any event at some subsequent time (which may be when such Securities are converted or exchanged or rights of subscription, purchase or acquisition are exercised or, as the case may be, such Securities are reclassified or redesignated or at such other time as may be provided), then for the purposes of this paragraph (b)(vii), “C” shall be determined by the application of such formula or variable feature or as if the relevant event occurs or had occurred as at the Specified Date and as if such conversion, exchange, subscription, purchase or acquisition, reclassification or, as the case may be, redesignation had taken place on the Specified Date.

Such adjustment shall become effective on the Effective Date.

“**Effective Date**” means, in respect of this paragraph (b)(vii), the later of (i) the date of issue of such Securities or, as the case may be, the grant of such rights and (ii) the first date upon which the adjusted Exchange Price is capable of being determined in accordance with this paragraph (b)(vii).

(viii) *Modification of rights*

If and whenever there shall be any modification of the rights of conversion, exchange, subscription, purchase or acquisition attaching to any Securities (other than the Bonds, which term shall for this purpose include any Further Bonds) which by their terms of issue carry (directly

or indirectly) rights of conversion into, or exchange or subscription for, or the right to otherwise acquire, any Ordinary Shares (other than in accordance with the terms (including terms as to adjustment) applicable to such Securities upon issue) so that following such modification the consideration per Ordinary Share (based, where appropriate, on such number of Ordinary Shares as is determined pursuant to the definition of “C” and the *proviso* below) receivable upon conversion, exchange, subscription, purchase or acquisition has been reduced and is less than 95 per cent. of the Current Market Price per Ordinary Share on the date of first public announcement of the terms for such modification, the Exchange Price shall be adjusted by multiplying the Exchange Price in force immediately prior to the Effective Date by the following fraction:

$$\frac{A + B}{A + C}$$

where:

- A is the number of Ordinary Shares in issue immediately before the date of first public announcement of the terms for such modification;
- B is the number of Ordinary Shares which the aggregate consideration (if any) receivable for the Ordinary Shares to be issued or otherwise made available upon conversion or exchange or upon exercise of the right of subscription, purchase or acquisition attached to the Securities so modified would purchase at such Current Market Price per Ordinary Share or, if lower, the existing conversion, exchange, subscription, purchase or acquisition price or rate of such Securities; and
- C is the maximum number of Ordinary Shares which may be issued or otherwise made available upon conversion or exchange of such Securities or upon the exercise of such rights of subscription, purchase or acquisition attached thereto at the modified conversion, exchange, subscription, purchase or acquisition price or rate but giving credit in such manner as the Calculation Agent shall consider appropriate for any previous adjustment under this paragraph (b)(viii) or paragraph (b)(vii) above;

provided that if on the date of first public announcement of the terms of such modification (as used in this paragraph (b)(viii), the “**Specified Date**”) such number of Ordinary Shares is to be determined by reference to the application of a formula or other variable feature or the occurrence of any event at some subsequent time (which may be when such Securities are converted or exchanged or rights of subscription, purchase or acquisition are exercised or at such other time as may be provided), then for the purposes of this paragraph (b)(viii), “C” shall be determined by the application of such formula or variable feature or as if the relevant event occurs or had occurred as at the Specified Date and as if such conversion, exchange, subscription, purchase or acquisition had taken place on the Specified Date.

Such adjustment shall become effective on the Effective Date.

“**Effective Date**” means, in respect of this paragraph (b)(viii), the later of (i) the date of modification of the rights of conversion, exchange, subscription, purchase or acquisition attaching to such Securities and (ii) the first date upon which the adjusted Exchange Price is capable of being determined in accordance with this paragraph (b)(viii).

(ix) *Certain arrangements*

If and whenever the Parent Guarantor or any Subsidiary of the Parent Guarantor or (at the direction or request of or pursuant to any arrangements with the Parent Guarantor or any

Subsidiary of the Parent Guarantor) any other company, person or entity shall offer any Securities in connection with which Shareholders as a class are entitled to participate in arrangements whereby such Securities may be acquired by them (except where the Exchange Price falls to be adjusted under paragraphs (b)(ii), (b)(iii), (b)(iv), (b)(v), (b)(vi) or (b)(vii) above or (b)(x) below (or, where applicable, would fall to be so adjusted if the relevant issue or grant was at less than 95 per cent. of the Current Market Price per Ordinary Share on the relevant day), the Exchange Price shall be adjusted by multiplying the Exchange Price in force immediately prior to the Effective Date by the following fraction:

$$\frac{A-B}{A}$$

where:

- A is the Current Market Price of one Ordinary Share on the Ex-Date in respect of the relevant offer; and
- B is the Fair Market Value on such Ex-Date of the portion of the relevant offer attributable to one Ordinary Share.

Such adjustment shall become effective on the Effective Date.

“**Effective Date**” means, in respect of this paragraph (b)(ix), the later of (i) the Ex-Date in respect of the relevant offer and (ii) the first date upon which the adjusted Exchange Price is capable of being determined in accordance with this paragraph (b)(ix).

(x) *Relevant Event*

If a Relevant Event shall occur, then upon any exercise of Conversion Rights (a) during the Relevant Event Period; or (b) on a date following the giving by the Issuer of an Optional Redemption Notice pursuant to Condition 7(b)(i) in circumstances where the precondition specified in Condition 7(b)(i) would not have been satisfied assuming (solely for the purpose of this proviso (b)) that the Parity Value in respect of the relevant dealing days had been determined only on the basis of the Exchange Price in effect (but not using the Relevant Event Exchange Price where applicable), the Exchange Price solely for the purpose of such exercise (the “**Relevant Event Exchange Price**”) shall be determined by multiplying the Exchange Price in force on such Conversion Date by the following fraction:

$$1/(1+ (EP \times c/t))$$

where:

- EP = means 37.5 per cent.
- c = means the number of calendar days from and including the date the Relevant Event occurs to but excluding the Final Maturity Date
- t = means the number of calendar days from and including the Closing Date to but excluding the Final Maturity Date

(xi) *Other adjustments*

If the Parent Guarantor (following consultation with the Calculation Agent) determines that an adjustment should be made to the Exchange Price (or that a determination should be made as to whether an adjustment should be made) as a result of one or more circumstances not referred to above in this Condition 6(b) (even if the relevant circumstance is specifically excluded from the

operation of paragraphs (b)(i) to (x) above), the Parent Guarantor shall, at its own expense and acting reasonably, request an Independent Adviser to determine, in consultation with the Calculation Agent, if different as soon as practicable what adjustment (if any) to the Exchange Price is fair and reasonable to take account thereof and the date on which such adjustment (if any) should take effect and upon such determination such adjustment (if any) shall be made and shall take effect in accordance with such determination, provided that an adjustment shall only be made pursuant to this paragraph (b)(xi) if such Independent Adviser is so requested to make such a determination not more than 21 days after the date on which the relevant circumstance arises and if the adjustment would result in a reduction to the Exchange Price.

(xii) *Modifications*

Notwithstanding the foregoing provisions:

- (a) where the events or circumstances giving rise to any adjustment pursuant to this Condition 6(b) have already resulted or will result in an adjustment to the Exchange Price or where the events or circumstances giving rise to any adjustment arise by virtue of any other events or circumstances which have already given or will give rise to an adjustment to the Exchange Price or where more than one event which gives rise to an adjustment to the Exchange Price occurs within such a short period of time that in the opinion of the Parent Guarantor, following consultation with the Calculation Agent, a modification to the operation of the adjustment provisions is required to give the intended result, such modification shall be made to the operation of the adjustment provisions as may be determined in good faith by an Independent Adviser to be in its opinion appropriate to give the intended result;
- (b) such modification shall be made to the operation of these Conditions as may be determined in good faith by an Independent Adviser, in consultation with the Calculation Agent (if different), to be in its opinion appropriate (i) to ensure that an adjustment to the Exchange Price or the economic effect thereof shall not be taken into account more than once and (ii) to ensure that the economic effect of a Dividend is not taken into account more than once; and
- (c) other than pursuant to Condition 6(b)(i), no adjustment shall be made that would result in an increase to the Exchange Price.

(xiii) *Calculation of consideration*

For the purpose of any calculation of the consideration receivable or price pursuant to paragraphs (b)(iv), (b)(vi), (b)(vii) and (b)(viii), the following provisions shall apply:

- (a) the aggregate consideration receivable or price for Ordinary Shares issued for cash shall be the amount of such cash;
- (b) (x) the aggregate consideration receivable or price for Ordinary Shares to be issued or otherwise made available upon the conversion or exchange of any Securities shall be deemed to be the consideration or price received or receivable for any such Securities (whether on one or more occasions) and (y) the aggregate consideration receivable or price for Ordinary Shares to be issued or otherwise made available upon the exercise of rights of subscription attached to any Securities or upon the exercise of any options, warrants or rights shall be deemed to be that part (which may be the whole) of the consideration or price received or receivable for such Securities or, as the case may be, for such options, warrants or rights which are attributed by the Parent Guarantor to such rights of

subscription or, as the case may be, such options, warrants or rights or, if no part of such consideration or price is so attributed, the Fair Market Value of such rights of subscription or, as the case may be, such options, warrants or rights as at the relevant Ex-Date referred to in paragraph (b)(iv) or as at the relevant date of first public announcement referred to in paragraph (b)(vi), (b)(vii) or (b)(viii), as the case may be, plus in the case of each of (x) and (y) above, the additional minimum consideration receivable or price (if any) upon the conversion or exchange of such Securities, or upon the exercise of such rights of subscription attached thereto or, as the case may be, upon exercise of such options, warrants or rights and (z) the consideration receivable or price per Ordinary Share upon the conversion or exchange of, or upon the exercise of such rights of subscription attached to, such Securities or, as the case may be, upon the exercise of such options, warrants or rights shall be the aggregate consideration or price referred to in (x) or (y) above (as the case may be) divided by the number of Ordinary Shares to be issued upon such conversion or exchange or exercise at the initial conversion, exchange or subscription price or rate, all as determined in good faith by the Calculation Agent;

- (c) if the consideration or price determined pursuant to (a) or (b) above (or any component thereof) shall be expressed in a currency other than the Relevant Currency (other than in circumstances where such consideration is also expressed in the Relevant Currency, in which case such consideration shall be treated as expressed in the Relevant Currency in an amount equal to the amount of such consideration when so expressed in the Relevant Currency), it shall be converted by the Calculation Agent into the Relevant Currency at the Prevailing Rate on the relevant Ex-Date (for the purposes of paragraph (b)(iv)) or the relevant date of first public announcement (for the purposes of paragraph (b)(vi), (vii) or (viii), as the case may be);
- (d) in determining the consideration or price pursuant to the above, no deduction shall be made for any commissions or fees (howsoever described) or any expenses paid or incurred for any underwriting, placing or management of the issue of the relevant Ordinary Shares or Securities or options, warrants or rights, or otherwise in connection therewith;
- (e) the consideration or price shall be determined as provided above on the basis of the consideration or price received, receivable, paid or payable, regardless of whether all or part thereof is received, receivable, paid or payable by or to the Parent Guarantor or another entity;
- (f) if as part of the same transaction, Ordinary Shares shall be issued or issuable for a consideration receivable in more than one or in different currencies then the consideration receivable per Ordinary Share shall be determined by dividing the aggregate consideration (determined as aforesaid and converted, if and to the extent not in the Relevant Currency, into the Relevant Currency as aforesaid) by the aggregate number of Ordinary Shares so issued; and
- (g) references in these Conditions to “cash” shall be construed as cash consideration within the meaning of Section 583(3) of the Companies Act.

(c) *Retroactive Adjustments*

If a Retroactive Adjustment occurs in relation to any exercise of Conversion Rights, the Parent Guarantor shall procure that there shall be issued to the relevant Bondholder upon exchange of the relevant Preference Shares, in accordance with the instructions contained in the relevant Conversion Notice, such

additional number of Ordinary Shares (if any) (the “**Additional Ordinary Shares**”) as, together with the Ordinary Shares issued on the relevant exercise of Conversion Rights, is equal to the number of Ordinary Shares which would have been required to be issued on such exchange if the relevant adjustment to the Exchange Price had been made and become effective immediately prior to the relevant Conversion Date, all as determined in good faith by the Calculation Agent or an Independent Adviser, provided that if in the case of paragraph (b)(ii), (b)(iii), (b)(iv), (b)(v) or (b)(ix) the relevant Bondholder shall be entitled to receive the relevant Ordinary Shares, Dividends or Securities in respect of the Reference Shares to be issued to it, then no such Retroactive Adjustment shall be made in relation to the relevant event and the relevant Bondholder shall not be entitled to receive Additional Ordinary Shares in relation thereto.

(d) *Decision and Determination of the Calculation Agent or an Independent Adviser*

Adjustments to the Exchange Price shall be determined and calculated by the Calculation Agent upon request from the Parent Guarantor and/or, to the extent so specified in the Conditions and upon request from the Parent Guarantor, by an Independent Adviser.

Adjustments to the Exchange Price calculated by the Calculation Agent or, where applicable, an Independent Adviser and any other determinations made by the Calculation Agent or, where applicable, an Independent Adviser, or an opinion of an Independent Adviser, pursuant to these Conditions shall in each case be made in good faith and shall be final and binding (in the absence of manifest error) on the Issuer, the Guarantors, the Trustee, the Bondholders, the Calculation Agent (in the case of a determination by an Independent Adviser) and the Paying, Transfer and Conversion Agents.

The Calculation Agent may consult, at the expense of the Parent Guarantor, on any matter (including, but not limited to, any legal matter), any legal or other professional adviser and it shall be able to rely upon, and it shall not be liable and shall incur no liability as against the Trustee, the Bondholders or the Paying, Transfer and Conversion Agents in respect of anything done, or omitted to be done, relating to that matter in good faith in accordance with that adviser’s opinion.

The Calculation Agent shall act solely upon the request from, and exclusively as agent of, the Issuer and the Parent Guarantor in accordance with these Conditions. Neither the Calculation Agent (acting in such capacity) nor any Independent Adviser appointed in connection with the Bonds (acting in such capacity) will thereby assume any obligations towards or relationship of agency or trust and shall not be liable and shall incur no liability in respect of anything done, or omitted to be done in good faith, in its capacity as Calculation Agent as against the Trustee, the Bondholders or the Paying, Transfer and Conversion Agents.

If following consultation between the Issuer, the Parent Guarantor and the Calculation Agent any doubt shall arise as to whether an adjustment falls to be made to the Exchange Price or as to the appropriate adjustment to the Exchange Price, following consultation between the Issuer, the Parent Guarantor and an Independent Adviser, a written opinion of such Independent Adviser in respect thereof shall be conclusive and binding on the Issuer, the Guarantors, the Bondholders, the Calculation Agent (if different) and the Trustee, save in the case of manifest error.

(e) *Share or Option Schemes, Dividend Reinvestment Plans*

No adjustment will be made to the Exchange Price where Ordinary Shares or other Securities (including, but not limited to, rights, warrants and options) are issued, offered, exercised, allotted, purchased, appropriated, modified or granted (i) to, or for the benefit of, employees or former employees (including directors holding or formerly holding executive office or non-executive office, consultants or former consultants, or the personal service company of any such person) or their spouses or relatives, in each

case, of the Parent Guarantor or any of its Subsidiaries or any associated company or to a trustee or nominee to be held for the benefit of any such person, in any such case pursuant to any share or option or incentive scheme or (ii) pursuant to any dividend reinvestment plan or similar plan or scheme.

(f) Rounding Down and Notice of Adjustment to the Exchange Price

On any adjustment, the resultant Exchange Price, if not an integral multiple of U.S.\$0.0001, shall be rounded down to the nearest whole multiple of U.S.\$0.0001. No adjustment shall be made to the Exchange Price where such adjustment (rounded down if applicable) would be less than one per cent. of the Exchange Price then in effect. Any adjustment not required to be made and/or any amount by which the Exchange Price has been rounded down (together with any adjustment to the Exchange Price of the Original Bonds not required to be made and/or any amount by which the Exchange Price of the Original Bonds has been rounded down, in each case as at the issue date of the New Bonds), shall be carried forward and taken into account in any subsequent adjustment, and such subsequent adjustment shall be made on the basis that the adjustment not required to be made had been made at the relevant time and/or, as the case may be, that the relevant rounding down had not been made.

Notice of any adjustments to the Exchange Price shall be given by the Parent Guarantor to Bondholders and to the Trustee promptly after the determination thereof.

The Exchange Price shall not in any event be reduced to below the nominal or par value of the Ordinary Shares or be reduced so that on conversion of the Bonds to Preference Shares and resulting exchange of the Preference Shares for Ordinary Shares, Ordinary Shares would fall to be issued in circumstances not permitted by applicable laws or regulations. The Parent Guarantor undertakes that it shall not take any action, and shall procure that no action is taken, that would otherwise result in an adjustment to the Exchange Price to below such nominal or par value or any minimum level permitted by applicable laws or regulations or that would otherwise result in Ordinary Shares being required to be issued in circumstances not permitted by applicable laws or regulations.

(g) Relevant Event

Within 10 calendar days following the occurrence of a Relevant Event, the Parent Guarantor shall give or procure notice thereof to Bondholders and to the Trustee (a “**Relevant Event Notice**”). The Relevant Event Notice shall contain a statement informing Bondholders of their entitlement to exercise their Conversion Rights as provided in these Conditions and their entitlement to exercise their rights to require redemption of their Bonds pursuant to Condition 7(e).

The Relevant Event Notice shall also specify:

- (i) all information material to Bondholders concerning the Relevant Event;
- (ii) the Exchange Price immediately prior to the occurrence of the Relevant Event and the Relevant Event Exchange Price applicable pursuant to Condition 6(b)(x) on the basis of the Exchange Price in effect immediately prior to the occurrence of the Relevant Event;
- (iii) the Closing Price of the Ordinary Shares as at the latest practicable date prior to the publication of the Relevant Event Notice;
- (iv) the Relevant Event Period;
- (v) the Relevant Event Put Date; and
- (vi) such other information relating to the Relevant Event as the Trustee may require.

The Trustee shall not be required to monitor or take any steps to ascertain whether a Relevant Event or any event which could lead to a Relevant Event has occurred or may occur and will not be responsible or liable to Bondholders or any other person for any loss arising from any delay or failure by it to do so.

(h) Procedure for exercise of Conversion Rights

Conversion Rights may be exercised by a Bondholder (provided that the relevant Conversion Date falls during the Conversion Period) by delivering the relevant Bond to the specified office of any Paying, Transfer and Conversion Agent, during its usual business hours, accompanied by a duly completed and signed notice of conversion (a “**Conversion Notice**”) in the form (for the time being current) obtainable from any Paying, Transfer and Conversion Agent. Conversion Rights shall be exercised subject in each case to any applicable fiscal or other laws or regulations applicable in the jurisdiction in which the specified office of the Paying, Transfer and Conversion Agent to whom the relevant Conversion Notice is delivered is located. A Conversion Notice can be deemed received by the Paying, Transfer and Conversion Agent if sent by electronic means.

If such delivery is made after the end of normal business hours or on a day which is not a business day in the place of the specified office of the relevant Paying, Transfer and Conversion Agent, such delivery shall be deemed for all purposes of these Conditions to have been made on the next following business day in such place.

Any determination as to whether any Conversion Notice has been duly completed and properly delivered shall be made by the relevant Paying, Transfer and Conversion Agent and shall, save in the case of manifest error, be conclusive and binding on the Issuer, the Guarantors, the Trustee, the Paying, Transfer and Conversion Agents and the relevant Bondholder.

Conversion Rights may only be exercised in respect of the whole of a Bond.

A Conversion Notice, once delivered, shall be irrevocable.

The conversion date in respect of a Bond (the “**Conversion Date**”) shall be the business day in London immediately following the date of the delivery (or deemed delivery) of the relevant Bond and the Conversion Notice as provided in this Condition 6(h) and shall be deemed to be the date on which the Conversion Right is exercised in respect of such Bond.

The Issuer or the Parent Guarantor shall pay all capital, stamp, issue and registration and transfer taxes and duties payable in Mauritius or the United Kingdom, or in any other jurisdiction in which the Issuer or Parent Guarantor may be domiciled or resident or to whose taxing jurisdiction it may be generally subject, in respect of the allotment and issue of Preference Shares or on transfer of any Preference Shares to the Parent Guarantor on exchange of the Preference Shares or in respect of the allotment, issue and delivery of any Ordinary Shares on exchange of the Preference Shares (including any Additional Ordinary Shares) (“**Specified Taxes**”). If the Issuer (failing which the Parent Guarantor) shall fail to pay any Specified Taxes, the relevant holder shall be entitled to tender and pay the same and the Issuer (failing which the Parent Guarantor) as a separate and independent stipulation, covenants to reimburse and indemnify each Bondholder in respect of any payment thereof and any penalties payable and costs incurred in respect thereof.

A Bondholder exercising Conversion Rights must pay directly to the relevant authorities any capital, stamp, issue, registration and transfer taxes and duties arising on the exercise of Conversion Rights (other than any Specified Taxes). A Bondholder must also pay all, if any, taxes imposed on it and arising by reference to any disposal or deemed disposal by it of a Bond or Preference Share or interest therein in connection with the exercise of Conversion Rights by it and the exchange of the resulting Preference

Shares (other than any Specified Taxes). Any such capital, stamp, issue, registration, transfer taxes or duties or other taxes payable by a Bondholder are referred to as “**Bondholder Taxes**”.

Neither the Trustee, the Calculation Agent nor any Paying, Transfer and Conversion Agent shall be responsible for determining whether any Specified Taxes or Bondholder Taxes are payable or the amount thereof and shall not be responsible or liable for any failure by the Parent Guarantor to pay such Specified Taxes or by a Bondholder to pay such Bondholder Taxes.

Ordinary Shares to be issued on exchange of Preference Shares (including any Additional Ordinary Shares) will be issued or delivered in uncertificated form through the dematerialised securities trading system operated by Euroclear UK & Ireland Limited, known as CREST, unless, at the time of issue, the Ordinary Shares are not a participating security in CREST, in which case the Ordinary Shares will be issued or delivered in certificated form. Where Ordinary Shares are to be issued or delivered through CREST, they will be delivered to the account specified by the relevant Bondholder in the relevant Conversion Notice by not later than seven London business days following the relevant Conversion Date (or, in the case of any Additional Ordinary Shares, not later than seven London business days following the relevant Reference Date). Where Ordinary Shares are to be issued or delivered in certificated form, a certificate in respect thereof will be dispatched by mail free of charge (but uninsured and at the risk of the recipient) to the relevant Bondholder or as it may direct in the relevant Conversion Notice within 28 days following the relevant Conversion Date or, as the case may be, the Reference Date.

Ordinary Shares to be issued on exchange of the Preference Shares will not be available for issue or delivery (i) to, or to a nominee or agent for, Euroclear Bank SA/NV or Clearstream Banking S.A. or any other person providing a clearance service within the meaning of Section 96 of the Finance Act 1986 of the United Kingdom or (ii) to a person, or nominee or agent for a person, whose business is or includes issuing depositary receipts within the meaning of Section 93 of the Finance Act 1986 of the United Kingdom, in each case, at any time prior to the “abolition day” as defined in Section 111(1) of the Finance Act 1990 of the United Kingdom.

Notwithstanding any other provisions of these Conditions, a Bondholder exercising Conversion Rights following a Change of Control Conversion Right Amendment as described in Condition 11(b)(vii) will be deemed, for the purposes of these Conditions, to have received the Ordinary Shares to be given to it by the Parent Guarantor in consideration for the Preference Shares arising on conversion of its Bonds in the manner provided in these Conditions, and have exchanged such Ordinary Shares for the consideration that it would have received therefor if it had exercised its Conversion Right in respect of such Bonds at the time of the occurrence of the relevant Change of Control Event.

(i) *Ordinary Shares*

Ordinary Shares (including any Additional Ordinary Shares) issued upon exchange of Preference Shares on exercise of Conversion Rights will be fully paid and will in all respects rank *pari passu* with the fully paid Ordinary Shares in issue on the relevant Conversion Date or, in the case of Additional Ordinary Shares, on the relevant Reference Date, and the relevant holder shall be entitled to all rights, distribution or payments the record date or other due date for the establishment of entitlement for which falls on or after the relevant Conversion Date, or as the case may be, the relevant Reference Date, except in any such case for any right excluded by mandatory provisions of applicable law or as otherwise may be provided in these Conditions. Such Ordinary Shares or, as the case may be, Additional Ordinary Shares will not rank for (or, as the case may be, the relevant holder shall not be entitled to receive) any rights, distributions or payments the record date or other due date for the establishment of entitlement for which falls prior to the relevant Conversion Date or, as the case may be, the relevant Reference Date.

(j) *Preference Shares*

Preference Shares allotted pursuant to these Conditions will be fully paid and will rank *pari passu* with all (if any) fully paid Preference Shares then in issue except that the Preference Shares so allotted will not rank for any dividend or other distribution declared, paid or made by reference to a record date prior to the relevant Conversion Date.

(k) *Interest on Conversion*

Save as provided below, no payment or adjustment shall be made on exercise of Conversion Rights for any interest which otherwise would have accrued on the relevant Bonds since the last Interest Payment Date preceding the Conversion Date relating to such Bonds (or, if such Conversion Date falls before the first Interest Payment Date, since the Closing Date).

If any notice requiring the redemption of the Bonds is given pursuant to Condition 7(b) or 7(c) on or after the fifteenth London business day prior to a record date or other due date for establishment of entitlement which has occurred since the last Interest Payment Date (or in the case of the first Interest Period, since the Closing Date) in respect of any Dividend or distribution payable in respect of the Ordinary Shares where such notice specifies a date for redemption falling on or prior to the date which is 14 London Business days after the Interest Payment Date next following such record date or other due date for establishment of entitlement, interest shall accrue at the rate provided in Condition 5(a) on Bonds in respect of which Conversion Rights shall have been exercised and in respect of which the Conversion Date falls after such record date or other due date for establishment of entitlement and on or prior to the Interest Payment Date next following such record date in respect of such Dividend or distribution, in each case from and including the preceding Interest Payment Date (or, if such Conversion Date falls before the first Interest Payment Date, from the Closing Date) to but excluding such Conversion Date.

The Issuer shall pay any such interest by not later than 14 calendar days after the relevant Conversion Date by transfer to a U.S. dollar account in accordance with instructions given by the relevant Bondholder in the relevant Conversion Notice.

(l) *Purchase or Redemption of Ordinary Shares*

Each of the Issuer, the Parent Guarantor or any of the Parent Guarantor's other Subsidiaries may exercise such rights as it may from time to time enjoy (if any) to purchase or redeem or buy back any shares of the Parent Guarantor (including Ordinary Shares) or any depositary or other receipts or certificates representing the same without the consent of the Bondholders.

(m) *No Duty to Monitor*

Neither the Trustee, the Calculation Agent nor any Paying, Transfer and Conversion Agent shall be under any duty to monitor whether any event or circumstance has happened or exists or may happen or exist and which requires or may require an adjustment to be made to the Exchange Price or be responsible or liable to any person for any loss arising from any failure by any of them to do so. The Trustee, the Calculation Agent and the Paying, Transfer and Conversion Agents shall also not be responsible or liable to any person (other than in the case of the Calculation Agent, to the Issuer and the Parent Guarantor strictly in accordance with the relevant provisions of the Calculation Agency Agreement) for any

determination as to whether or not an adjustment to the Exchange Price is required or should be made nor for any determination or calculation of any such adjustment.

(n) *Consolidation, Amalgamation or Merger*

Without prejudice to Condition 6(b)(x), in the case of any consolidation, amalgamation or merger of the Parent Guarantor with any other corporation (other than constituting a Change of Control Event or a consolidation, amalgamation or merger in which the Parent Guarantor is the continuing corporation) (a “**Successor in Business**”), the Parent Guarantor will forthwith give notice thereof to Bondholders and to the Trustee of such event and will take and/or procure the taking of such steps as shall be required, subject to applicable law and as provided in the Trust Deed (including the execution of a deed supplemental to or amending the Trust Deed):

- (i) to ensure that the Successor in Business is substituted in place of the Parent Guarantor as the senior guarantor under the Bonds and the Trust Deed and as the obligor under the Deed Poll;
- (ii) to ensure that each Bond then outstanding will (during the period in which Conversion Rights may be exercised) be convertible into Preference Shares and that such Preference Shares shall (without any further action being required to be taken by, and without any cost or expense to, the relevant Bondholder, the Principal Paying, Transfer and Conversion Agent or the Trustee) automatically be deemed to be transferred on and as at the relevant Conversion Date from the relevant Bondholder to the Successor in Business and in consideration for which the Successor in Business shall issue to the relevant Bondholder equity share capital (or similar) of the Successor in Business, on such basis and with an Exchange Price (subject to adjustment as provided in these Conditions) economically equivalent to the Exchange Price existing immediately prior to the implementation of such consolidation, amalgamation or merger, as determined in good faith by an Independent Adviser (each a “**Conversion Right Transfer**”); and
- (iii) to ensure that the Trust Deed (as so amended or supplemented if applicable) and the Conditions provide at least the same or equivalent powers, protections, rights and benefits to the Trustee and the Bondholders following the implementation of such consolidation, amalgamation or merger as they provided to the Trustee and the Bondholders prior to the implementation of such consolidation, amalgamation or merger, *mutatis mutandis*.

The satisfaction of the requirements set out in subparagraphs (i), (ii) and (iii) of this Condition 6(n) by the Parent Guarantor is herein referred to as a “**Permitted Cessation of Business**”. Notwithstanding any other provision of these Conditions, a Permitted Cessation of Business shall not result in a breach of undertaking, constitute an Event of Default or otherwise result in any breach of any provision of these Conditions or the Trust Deed. Following the occurrence of a Permitted Cessation of Business, references in these Conditions, the Trust Deed and the Agency Agreement to the “Parent Guarantor” will be construed as references to the relevant Successor in Business.

At the request of the Parent Guarantor, but subject to the Parent Guarantor’s compliance with the provisions of subparagraph (i), (ii) and (iii) of this Condition 6(n), the Trustee shall (at the expense of the Parent Guarantor), without the requirement for any consent or approval of the Bondholders, be obliged to concur with the Parent Guarantor in effecting any substitution under subparagraph (i) above and Conversion Right Transfer (including, *inter alia*, the execution of a deed supplemental to or amending the Trust Deed), provided that the Trustee shall not be obliged so to concur if in the opinion of the Trustee doing so would impose more onerous obligations upon it or expose it to any additional duties, responsibilities or liabilities or reduce or amend the protective provisions afforded to the Trustee

in these Conditions, the Trust Deed or the Agency Agreement (including, for the avoidance of doubt, any supplemental trust deed or supplemental agency agreement) in any way.

If, following consultation with the Calculation Agent, any doubt shall arise as to how determinations, calculations or adjustments as specifically required to be performed by the Calculation Agent in these Conditions should be performed following any such consolidation, amalgamation or merger, a written opinion of an Independent Adviser in respect thereof shall be conclusive and binding on the Successor in Business, the Issuer, the Guarantors, the Trustee, the Bondholders, the Calculation Agent and all other parties, save in the case of manifest error.

The above provisions of this Condition 6(n) will apply, *mutatis mutandis*, to any subsequent consolidations, amalgamation or mergers.

7 Redemption and Purchase

(a) Final Redemption

Unless previously purchased and cancelled, redeemed or converted as herein provided, the Bonds will be redeemed at their principal amount on the Final Maturity Date. The Bonds may only be redeemed at the option of the Issuer prior to the Final Maturity Date in accordance with Condition 7(b) or 7(c) and may only be redeemed by Bondholders prior to the Final Maturity Date in accordance with Condition 7(e).

(b) Redemption at the Option of the Issuer

Subject as provided in Condition 7(d), on giving not less than 30 nor more than 60 days' notice (an "**Optional Redemption Notice**") to Bondholders, the Principal Paying, Transfer and Conversion Agent and to the Trustee, the Issuer may redeem all but not some only of the Bonds on the date (the "**Optional Redemption Date**") specified in the Optional Redemption Notice at their principal amount, together with accrued but unpaid interest up to (but excluding) the Optional Redemption Date:

- (i) at any time on or after 8 April 2026 (the "**First Call Date**"), if the Parity Value on each of at least 20 dealing days in any period of 30 consecutive dealing days ending no more than five London business days prior to the giving of the relevant Optional Redemption Notice, shall have exceeded U.S.\$260,000, as verified by the Calculation Agent upon request by the Issuer; or
- (ii) at any time if, prior to the date the relevant Optional Redemption Notice is given, Conversion Rights shall have been exercised and/or purchases (and corresponding cancellations) and/or redemptions effected in respect of 85 per cent. or more in principal amount of the Bonds originally issued (which shall for this purpose include any Further Bonds issued prior to the date the Optional Redemption Notice is given).

On the Optional Redemption Date, the Issuer shall redeem the Bonds at their principal amount, together with accrued interest up to (but excluding) the Optional Redemption Date.

(c) Redemption for Taxation Reasons

Subject as provided in Condition 7(d), and provided that the Bonds have been and remain "listed on a recognised stock exchange" (as such term is defined in Section 1005 of the Income Tax Act 2007) (the "**ITA 2007**") or admitted to trading on a "multilateral trading facility" operated by a UK or EEA-regulated recognised stock exchange (within the meaning of Sections 987 and 1005 of ITA 2007), the Issuer may, having given not less than 30 nor more than 60 days' notice (a "**Tax Redemption Notice**") to the Bondholders, the Principal Paying, Transfer and Conversion Agent and to the Trustee redeem

(subject to the second following paragraph) all but not some only of the Bonds for the time being outstanding on the date (the “**Tax Redemption Date**”) specified in the Tax Redemption Notice at their principal amount, together with accrued but unpaid interest up to (but excluding) the Tax Redemption Date, if (i) the Issuer satisfies the Trustee immediately prior to the giving of such notice that the Issuer, or, as the case may be, any Guarantor, has or will become obliged to pay additional amounts in respect of payments of interest on the Bonds pursuant to Condition 9, or the Guarantors would be unable for reasons outside of their control to procure payment by the Issuer and, in any Guarantor making payment itself, it would be required to pay such additional amounts, in each case as a result of any change in, or amendment to, the laws or regulations of a Relevant Jurisdiction, or any change in the general application or official interpretation of such laws or regulations of a Relevant Jurisdiction, which change or amendment becomes effective on or after 10 March 2021, and (ii) such obligation cannot be avoided by the Issuer or, as the case may be, the relevant Guarantor taking reasonable measures available to it, provided that no Tax Redemption Notice shall be given earlier than 90 days prior to the earliest date on which the Issuer or the relevant Guarantor, as the case may be, would be obliged to pay such additional amounts were a payment in respect of the Bonds then due or, as the case may be, the relevant Guarantee were called. Prior to the publication of any notice of redemption pursuant to this paragraph, the Issuer shall deliver to the Trustee (a) a certificate signed by two Authorised Signatories of the Issuer or the relevant Guarantor, as the case may be, stating that the obligation referred to in (i) above has arisen and cannot be avoided by the Issuer or the relevant Guarantor, as the case may be, taking reasonable measures available to it and (b) an opinion of independent legal or tax advisers of recognised international standing (which may be addressed to the Issuer or the Guarantor) to the effect that such change or amendment has occurred and that the Issuer or the relevant Guarantor, as the case may be, has or will be obliged to pay such additional amounts as a result thereof (irrespective of whether such amendment or change is then effective) and the Trustee shall be entitled to accept such certificate and opinion (without further enquiry and without any liability to any person for so doing) as sufficient evidence of the matters set out in (i) and (ii) above, in which event such certificate shall be conclusive and binding on the Bondholders.

On the Tax Redemption Date the Issuer shall (subject to the next following paragraph) redeem the Bonds at their principal amount, together with accrued interest up to (but excluding) the Tax Redemption Date.

If the Issuer gives a Tax Redemption Notice, each Bondholder will have the right to elect that its Bonds shall not be redeemed pursuant to such Tax Redemption Notice and that the provisions of Condition 9 shall not apply in respect of any payment of interest to be made on such Bonds which falls due after the relevant Tax Redemption Date, whereupon no additional amounts shall be payable in respect thereof pursuant to Condition 9 and payment of all amounts of such interest on such Bonds shall be made subject to the deduction or withholding required to be withheld or deducted by the laws or regulations of a Relevant Jurisdiction (and for the avoidance of doubt any deduction or withholding required to be withheld or deducted by the laws or regulations of a Relevant Jurisdiction of a Guarantor shall only be so deducted or withheld if the Guarantee in respect of that Guarantor is called and the Guarantors are unable for reasons outside of their control to procure payment by the Issuer). To exercise such right, the holder of the relevant Bond must complete, sign and deposit at the specified office of any Paying, Transfer and Conversion Agent a duly completed and signed notice of election, in the form for the time being current, obtainable from the specified office of any Paying, Transfer and Conversion Agent, together with the relevant Bonds, on or before the day falling 10 days prior to the Tax Redemption Date. Any Bond so deposited shall be returned by the relevant Paying, Transfer and Conversion Agent to the relevant Bondholder on the Tax Redemption Date endorsed to reflect the election made by such Bondholder by uninsured post to, and at the risk of, the relevant Bondholder.

References in this Condition 7(c) to the Relevant Jurisdiction shall be deemed also to include any jurisdiction in respect of which any undertaking or covenant equivalent to that in Condition 9 is given

pursuant to the Trust Deed, (except that as regards such jurisdiction the words “becomes effective on or after 10 March 2021” in Condition 7(c)(i) above shall be replaced with the words “becomes effective after, and has not been announced on or before, the date on which any undertaking or covenant equivalent to that in Condition 9 was given pursuant to the Trust Deed)” and references in this Condition 7(c) to additional amounts payable under Condition 9 shall be deemed also to refer to additional amounts payable under any such undertaking or covenant.

(d) *Optional Redemption and Tax Redemption Notices*

The Issuer shall not give an Optional Redemption Notice or Tax Redemption Notice at any time during a Relevant Event Period or an Offer Period or which specifies a date for redemption falling in a Relevant Event Period or an Offer Period or the period of 14 days following the end of an Offer Period (whether or not the relevant notice was given prior to or during such Relevant Event Period or Offer Period), and any such notice shall be invalid and of no effect (whether or not given prior to the relevant Relevant Event Period or Offer Period) and the relevant redemption shall not be made.

Any Optional Redemption Notice or Tax Redemption Notice shall be irrevocable. Any such notice shall specify (i) the Optional Redemption Date or, as the case may be, the Tax Redemption Date which shall be a London business day, (ii) the Exchange Price, the aggregate principal amount of the Bonds outstanding and the Closing Price of the Ordinary Shares, in each case as at the latest practicable date prior to the publication of the Optional Redemption Notice or, as the case may be, the Tax Redemption Notice and (iii) the last day on which Conversion Rights may be exercised by Bondholders.

“**Offer Period**” means (i) any period commencing on the date of first public announcement of an offer or tender (howsoever described) by any person or persons in respect of all or a majority of the issued and outstanding Ordinary Shares and ending on the date that offer or tender ceases to be open for acceptance or, if earlier, on which that offer or tender lapses or terminates or is withdrawn or (ii) any period commencing on the date of first public announcement of a Scheme of Arrangement relating to the acquisition of all or a majority of the issued and outstanding Ordinary Shares and ending on the date such Scheme of Arrangement is or becomes effective or, if earlier, the date such Scheme of Arrangement is cancelled or terminated or (iii) the period during which the Parent Guarantor is stated as being in an offer period on the Takeover Panel’s Disclosure Table on the Takeover Panel’s website.

(e) *Redemption at the Option of Bondholders*

Following the occurrence of a Relevant Event, the holder of each Bond will have the right to require the Issuer to redeem that Bond on the Relevant Event Put Date at its principal amount, together with accrued and unpaid interest up to (but excluding) the Relevant Event Put Date. To exercise such right, the holder of the relevant Bond must deliver such Bond to the specified office of any Paying, Transfer and Conversion Agent, together with a duly completed and signed notice of exercise in the form for the time being current obtainable from the specified office of any Paying, Transfer and Conversion Agent (a “**Relevant Event Put Exercise Notice**”), at any time during the Relevant Event Period.

The “**Relevant Event Put Date**” shall be the fourteenth London business day after the expiry of the Relevant Event Period.

Payment in respect of any such Bond shall be made by transfer to a U.S. dollar account as specified by the relevant Bondholder in the relevant Relevant Event Put Exercise Notice.

A Relevant Event Put Exercise Notice, once delivered, shall be irrevocable and the Issuer shall redeem all Bonds the subject of Relevant Event Put Exercise Notices delivered as aforesaid on the Relevant Event Put Date.

(f) *Purchase*

Subject to the requirements (if any) of any stock exchange on which the Bonds may be admitted to listing and trading at the relevant time and subject to compliance with applicable laws and regulations, the Issuer, the Parent Guarantor any other Subsidiary of the Parent Guarantor may at any time purchase any Bonds in the open market or otherwise at any price. Such Bonds may be held, resold or reissued or, at the option of the Issuer, surrendered to the Principal Paying, Transfer and Conversion Agent for cancellation.

(g) *Cancellation*

All Bonds which are redeemed or in respect of which Conversion Rights are exercised will be cancelled and may not be reissued or resold. Bonds purchased by the Issuer, any of the Guarantors or any of the other Subsidiaries of the Parent Guarantor may be surrendered to the Principal Paying, Transfer and Conversion Agent for cancellation and if so surrendered shall be cancelled and may not be reissued or re-sold.

(h) *Multiple Notices*

If more than one notice of redemption is given pursuant to this Condition 7, the first of such notices to be given shall prevail, save that a notice given pursuant to Condition 7(e) shall prevail over a notice given pursuant to Condition 7(b) or (c) in circumstances where the Relevant Event Put Date falls prior to the Optional Redemption Date or Tax Redemption Date, as the case may be.

8 **Payments**

(a) *Principal*

Payment of principal and interest in respect of the Bonds will be made to the persons shown in the Register at the close of business on the Record Date.

(b) *Other amounts*

Payments of all amounts other than as provided in Condition 8(a) will be made as provided in these Conditions.

(c) *Record Date*

“**Record Date**” means the fifth business day, in the place of the specified office of the Registrar, before the due date for the relevant payment.

(d) *Payments*

Each payment in respect of the Bonds pursuant to Condition 8(a) and (b) will be made by transfer to a U.S. dollar account maintained by the payee.

(e) *Payments subject to fiscal laws*

All payments in respect of the Bonds are subject in all cases (i) to any applicable fiscal or other laws and regulations applicable thereto in the place of payment, but without prejudice to Condition 9 and (ii) any withholding or deduction required pursuant to an agreement described in Section 1471(b) of the U.S. Internal Revenue Code of 1986, as amended (the “**Code**”), or otherwise imposed pursuant to Sections 1471 through 1474 of the Code and any regulations or agreements thereunder or official interpretations thereof (“**FATCA**”) or any law implementing an intergovernmental approach to FATCA.

(f) *Delay in payment*

Bondholders will not be entitled to any interest or other payment for any delay after the due date in receiving the amount due as a result of the due date not being a business day.

(g) *Paying, Transfer and Conversion Agents, Calculation Agent etc.*

The initial Paying, Transfer and Conversion Agents and Registrar and their initial specified offices are listed below. The Issuer and the Parent Guarantor reserve the right under the Agency Agreement at any time, with the prior written approval of the Trustee, to vary or terminate the appointment of any Paying, Transfer and Conversion Agent or the Registrar and appoint additional or other Paying, Transfer and Conversion Agents or another Registrar, provided that they will (i) maintain a Principal Paying, Transfer and Conversion Agent, and (ii) maintain a Registrar with a specified office outside the United Kingdom. Notice of any change in the Paying, Transfer and Conversion Agents or the Registrar or their specified offices will promptly be given by the Issuer to Bondholders. The Issuer and the Parent Guarantor reserve the right, subject to the prior approval of the Trustee, under the Calculation Agency Agreement at any time to vary or terminate the appointment of the Calculation Agent and appoint another Calculation Agent, provided that they will maintain a Calculation Agent which shall be a financial institution of international repute or a financial adviser with appropriate expertise. Notice of any change in the Calculation Agent will promptly be given by the Issuer to Bondholders.

(h) *No charges*

Neither the Registrar nor the Paying, Transfer and Conversion Agents shall make or impose on a Bondholder any charge or commission in relation to any payment, transfer or conversion in respect of the Bonds.

(i) *Fractions*

When making payments to Bondholders, if the relevant payment is not of an amount which is a whole multiple of the smallest unit of the relevant currency in which such payment is to be made, such payment will be rounded down to the nearest unit.

*The Bonds on issue will be represented by a global bond (the "Global Bond") registered in the name of, and held by a nominee on behalf of, a common depositary for Euroclear Bank SA/NV ("**Euroclear**") and/or Clearstream Banking S.A. ("**Clearstream, Luxembourg**").*

All payments in respect of Bonds represented by the Global Bond will be made to, or to the order of, the person whose name is entered in the Register at the close of business on the Clearing System Business Day immediately prior to the date of payment, where "Clearing System Business Day" means Monday to Friday inclusive except 25 December and 1 January.

9 Taxation

All payments made by or on behalf of the Issuer, the Parent Guarantor or any Subsidiary Guarantor in respect of the Bonds will be made free and clear of and without deduction or withholding for, or on account of, any present or future taxes, duties, levies, impost, assessments or governmental charges (including penalties, interest and any other additions thereto) of whatever nature ("**Taxes**" and each, a "**Tax**") imposed or levied by or on behalf of any Relevant Jurisdiction, unless deduction or withholding of such Taxes is required to be made by law.

If any such withholding or deduction is required to be made, the Issuer, the Parent Guarantor or, as the case may be, the relevant Subsidiary Guarantor will pay such additional amounts as will result in the receipt by the

Bondholders of the amounts which would have been received by them had no such withholding or deduction been required, except that no such additional amounts shall be payable in respect of:

- (a) any Taxes to the extent such Taxes would not have been imposed but for the existence of any actual or deemed (pursuant to applicable Tax law of the relevant Tax Jurisdiction, such as, if applicable, a connection of a partnership that is attributed to the partners/beneficial owners) present or former connection between the holder or the beneficial owner of the Bonds and the relevant Tax Jurisdiction (including being a resident of such jurisdiction for Tax purposes), other than the holding of such Bond, the enforcement of rights under such Bond or under a Guarantee or the receipt of any payments in respect of such Bond or Guarantee;
- (b) any Taxes to the extent such Taxes were imposed as a result of the surrender of a Bond for payment more than 30 days after the relevant payment is first made available for payment to the Bondholder (except to the extent that the holder would have been entitled to additional amounts had the Bond been presented on the last day of such 30 day period);
- (c) any estate, inheritance, gift, sales, personal property, transfer or similar Taxes;
- (d) any Taxes to the extent such Taxes result from the surrender of a Bond for payment (where surrender is required) and the payment can be made without such withholding or deduction by the surrender of the Bond for payment elsewhere;
- (e) any Taxes, to the extent such Taxes were imposed or withheld by reason of the failure of the holder or beneficial owner of Bonds to comply with any reasonable written request of the Issuer addressed to the holder or beneficial owner and made at least 60 days before any such withholding or deduction would be payable, to satisfy any certification, identification, information or other reporting requirements, whether required by statute, treaty, regulation or administrative practice of a Tax Jurisdiction, as a precondition to exemption from, or reduction in the rate of deduction or withholding of, Taxes imposed by the Tax Jurisdiction (including, without limitation, a certification that the holder or beneficial owner is not resident in the Tax Jurisdiction), but in each case, only to the extent the holder or beneficial owner is legally entitled to provide such certification or documentation;
- (f) any Taxes imposed on or with respect to any payment by the Issuer or the relevant Guarantor to the holder if such holder is a fiduciary or partnership or person other than the sole beneficial owner of such payment, to the extent that Taxes would not have been imposed on such payment had such holder been the sole beneficial owner of such Bond; or
- (g) any combination of items (a) through (f) above.

References in these Conditions to principal and/or interest and/or any other amounts payable in respect of the Bonds shall be deemed also to refer to any additional amounts which may be payable under this Condition or any undertaking or covenant given in addition thereto or in substitution therefor pursuant to the Trust Deed.

The provisions of this Condition 9 shall not apply in respect of any payments of interest which fall due after the relevant Tax Redemption Date in respect of any Bonds which are the subject of a Bondholder election pursuant to Condition 7(c), provided that any deduction or withholding required to be withheld or deducted by the laws or regulations of a Relevant Jurisdiction of a Guarantor shall only be so deducted or withheld if the Guarantee in respect of that Guarantor is called and the Guarantors are unable for reasons outside of their control to procure payment by the Issuer.

Notwithstanding any other provision of these Conditions, in no event will the Issuer or any Guarantor be required to pay any additional amounts in respect of the Bonds for, or on account of, any withholding or

deduction required pursuant to FATCA (including pursuant to any agreement described in Section 1471(b) of the Code) or any law implementing an intergovernmental approach to FATCA.

10 Events of Default

If any of the following events (each an “**Event of Default**”) occurs and is continuing, the Trustee at its discretion may and, if so requested in writing by the holders of at least 25 per cent. in principal amount of the Bonds then outstanding or if so directed by an Extraordinary Resolution, shall (provided in each case that it is indemnified and/or secured and/or prefunded to its satisfaction), (but in the case of the happening of any of the events described in Condition 10(d), only if the Trustee shall have certified in writing to the Issuer that in its opinion such event is or is likely to be materially prejudicial to the interests of the Bondholders) give notice to the Issuer that the Bonds are, and they shall accordingly immediately become, due and repayable at their principal amount together with accrued interest (if any) to the date of payment:

- (a) default for 30 days in the payment when due of any interest or any additional amounts with respect to any Bond;
- (b) default in the payment when due of the principal of, or any premium, if any, on, any Bond (at maturity, upon redemption or otherwise);
- (c) the Issuer or the Parent Guarantor fails to deliver Preference Shares and/or Ordinary Shares following any exercise of Conversion Rights and such failure continues for 14 days (or such longer period as the Trustee may permit);
- (d) the Issuer or any Guarantor does not perform or comply with any one or more of its other obligations under the Bonds, the Trust Deed, the Deed Poll or, as the case may be, the Congo B Deed of Guarantee or if any event occurs or any action is taken or failed to be taken which is (or but for the provisions of any applicable law would be) a breach of any such obligation, and which default or breach is incapable of remedy or, if in the reasonable opinion of the Trustee capable of remedy, is not in the reasonable opinion of the Trustee remedied within 60 days (or such longer period as the Trustee may permit) after written notice of such default or breach shall have been given to the Issuer or the Parent Guarantor by the Trustee or the holders of at least 25 per cent. in aggregate principal amount of Bonds then outstanding (such notice copied to the Trustee) requiring the same to be remedied;
- (e) default which shall not have been cured or waived under the terms of any instrument evidencing or securing indebtedness for borrowed money of the Issuer or any Guarantor (or the payment of which is guaranteed by the Issuer or any Guarantor), whether such indebtedness or guarantee now exists or is created after the Closing Date, if that default:
 - (i) is caused by the failure to pay principal of such indebtedness following the expiration of any applicable grace period provided in such indebtedness and such failure to make payment has not been waived or the maturity of such indebtedness has not been extended (a “**Payment Default**”);
or
 - (ii) results in the acceleration of such indebtedness prior to its Stated Maturity,

and, in each case, the principal amount of any such indebtedness, together with the principal amount of any other such indebtedness under which there has been a Payment Default or the maturity of which has been so accelerated, individually or in the aggregate exceeds US\$30.0 million (or the equivalent in other currencies) at the relevant time;

- (f) failure by the Issuer, the Parent Guarantor or any Relevant Significant Subsidiary (as defined below) to pay final judgments entered by a court or courts of competent jurisdiction, which individually or in the aggregate exceed US\$30.0 million (or the equivalent in other currencies) (exclusive of any amounts that a solvent insurance company has acknowledged liability for), which judgments shall not have been discharged or waived and there shall have been a period of 60 consecutive days during which a stay of enforcement of such judgment or order, by reason of an appeal, waiver or otherwise, shall not have been in effect;
- (g) except as permitted by these Conditions, the Trust Deed and the Congo B Deed of Guarantee (including with respect to any limitations), (x) any Guarantee or the Deed Poll of the Parent Guarantor or any Guarantee of a Significant Subsidiary or the Guarantees of a group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary, is held in any judicial proceeding to be unenforceable or invalid or ceases for any reason to be in full force and effect; or (y) the Parent Guarantor or any Guarantor that is a Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary, or any person acting on behalf of any such Guarantor or Guarantors, denies or disaffirms its obligations under its Guarantee;
- (h) the entry by a court of competent jurisdiction of (A) a decree or order for relief in respect of the Issuer, the Parent Guarantor or any Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary, in an involuntary case or proceeding under any applicable Bankruptcy Law or (B) a decree or order adjudging the Issuer, the Parent Guarantor or any Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary, bankrupt or insolvent, or seeking reorganisation, arrangement, adjustment or composition of or in respect of the Issuer, the Parent Guarantor or any Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary, under any applicable law, or appointing a custodian, receiver, liquidator, assignee, trustee, sequestrator (or other similar official) of the Issuer, the Parent Guarantor or any Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary, or of any substantial part of their respective properties or ordering the winding up or liquidation of their affairs, and any such decree, order or appointment pursuant to any Bankruptcy Law for relief shall continue to be in effect, or any such other decree, appointment or order shall be unstayed and in effect, for a period of 60 consecutive days; or
- (i) (A) the Issuer, the Parent Guarantor or any Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary, (x) commences a voluntary case or proceeding under any applicable Bankruptcy Law or any other case or proceeding to be adjudicated bankrupt or insolvent or (y) consents to the filing of a petition, application, answer or consent seeking reorganisation or relief under any applicable Bankruptcy Law, (B) the Issuer, the Parent Guarantor or any Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary, consents to the entry of a decree or order for relief in respect of the Issuer, the Parent Guarantor or such Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary, in an involuntary case or proceeding under any applicable Bankruptcy Law or to the commencement of any bankruptcy or insolvency case or proceeding against it or, (C) the Issuer, the Parent Guarantor, or any Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary (x) consents to the appointment of, or taking possession by, a custodian, receiver, liquidator, administrator, supervisor, assignee, trustee, sequestrator or similar official of the Issuer, the Parent Guarantor or such Significant Subsidiary or any group of Subsidiary Guarantors that, taken together, would constitute a Significant Subsidiary or of any substantial part of their respective properties, or (y) makes an assignment for the benefit of creditors.

For purposes of this Condition 10:

“**Bankruptcy Law**” means (i) the UK Insolvency Act 1986, as amended (together with the rules and regulations made pursuant thereto), (ii) title 11, United States Bankruptcy Code of 1978, as amended and (iii) any other applicable law relating to bankruptcy, insolvency, receivership, winding up, liquidation, reorganisation or relief of debtors.

“**Comparable Refinancing Note**” has the meaning given to it in Condition 2.

“**Relevant Significant Subsidiary**” means at any time:

- (i) for so long as any Existing Senior Notes or Comparable Refinancing Notes are outstanding, any Restricted Subsidiary that is a Significant Subsidiary or a group of Restricted Subsidiaries that, taken together, would constitute a Significant Subsidiary; or
- (ii) if no Existing Senior Notes or Comparable Refinancing Notes are outstanding, a Significant Subsidiary.

“**Restricted Subsidiary**” has the meaning given to it in Condition 2.

“**Significant Subsidiary**” has the meaning given to it in Condition 2.

“**Stated Maturity**” means, with respect to any series of indebtedness for borrowed money, the date on which the payment of principal was scheduled to be paid in the documentation governing such indebtedness as of the Closing Date, and will not include any contingent obligations to repay, redeem or repurchase any such principal prior to the date originally scheduled for the payment thereof.

11 Undertakings

Whilst any Conversion Right remains exercisable, the Parent Guarantor will, save with the approval of an Extraordinary Resolution or the prior written approval of the Trustee or, in the case of a modification to the Deed Poll, unless the modification is approved by an Extraordinary Resolution or approved by the Trustee as provided in Condition 14(b), perform all of its obligations under, and not make any modification to, the Deed Poll.

Whilst any Conversion Right remains exercisable, the Parent Guarantor will, save with the approval of an Extraordinary Resolution or with the prior written approval of the Trustee where, in its opinion, it is not or not likely to be materially prejudicial to the interests of the Bondholders to give such approval:

- (a) not issue or pay up any Securities, in either case by way of capitalisation of profits or reserves, other than:
 - (i) pursuant to a Scheme of Arrangement involving a reduction and cancellation of Ordinary Shares and the issue to Shareholders of an equal number of Ordinary Shares by way of capitalisation of profits or reserves; or
 - (ii) pursuant to or in connection with a Newco Scheme; or
 - (iii) by the issue of fully paid Ordinary Shares or other Securities to Shareholders and other holders of shares in the capital of the Parent Guarantor which by their terms entitle the holders thereof to receive Ordinary Shares or other Securities on a capitalisation of profits or reserves; or
 - (iv) by the issue of fully paid Ordinary Shares, issued wholly, ignoring fractional entitlements, in lieu of the whole or part of a Dividend in cash; or
 - (v) by the issue of Ordinary Shares or any equity share capital to, or for the benefit of, employees or former employees, director or executive holding or formerly holding executive office (including

directors holding or formerly holding executive office or non-executive office, consultants or former consultants or the personal service company of any such person) or their spouses or relatives, in each case of the Parent Guarantor or any of its Subsidiaries or any associated company or to a trustee or nominee to be held for the benefit of any such person, in any such case pursuant to an employee, contractor, director or executive share or option or incentive scheme whether for all employees, contractors, directors or executives or any one or more of them,

(i) to (v) above each being a “**Permitted Issue**”, unless, in any such case, the same constitutes a Dividend or otherwise falls to be taken into account for a determination as to whether an adjustment is to be made to the Exchange Price pursuant to Condition 6(b), regardless of whether in fact an adjustment falls to be made in respect of the relevant capitalisation, gives rise (or would, but for the provisions of Condition 6(f) relating to roundings and minimum adjustments or the carry forward of adjustments, give rise) to an adjustment to the Exchange Price;

(b) not modify the rights attaching to the Ordinary Shares with respect to voting, dividends or liquidation nor issue any other class of equity share capital carrying any rights which are more favourable than the rights attaching to the Ordinary Shares but so that nothing in this Condition 11(b) shall prevent:

(i) any consolidation, reclassification, redesignation or subdivision of the Ordinary Shares; or

(ii) any modification of such rights which is not, in the opinion of an Independent Adviser acting in good faith, materially prejudicial to the interests of the holders of the Bonds; or

(iii) any issue of equity share capital where the issue of such equity share capital results, or would, but for the provisions of Condition 6(f) relating to roundings and minimum adjustments or the carry forward of adjustments or, where comprising Ordinary Shares, the fact that the consideration per Ordinary Share receivable therefor is at least 95 per cent. of the Current Market Price per Ordinary Share at the relevant time for determination thereof pursuant to the relevant provisions of Condition 6(b), otherwise result, in an adjustment to the Exchange Price; or

(iv) without prejudice to any rule of law or legislation (including regulations made under Sections 783, 784(3), 785 and 788 of the Companies Act or any other provision of that or any other legislation), the conversion of Ordinary Shares into, or the issue of any Ordinary Shares in, uncertificated form (or the conversion of Ordinary Shares in uncertificated form to certificated form) or the amendment of the Articles of Association to enable title to securities (including Ordinary Shares) to be evidenced and transferred without a written instrument or any other alteration to the Articles of Association made in connection with the matters described in this Condition 11(b) or which is supplemental or incidental to any of the foregoing (including any amendment made to enable or facilitate procedures relating to such matters and any amendment dealing with the rights and obligations of holders of Securities, including Ordinary Shares, dealt with under such procedures); or

(v) any issue of equity share capital or modification of rights attaching to the Ordinary Shares, where prior thereto the Parent Guarantor shall have instructed an Independent Adviser to determine what (if any) adjustments should be made to the Exchange Price as being fair and reasonable to take account thereof and such Independent Adviser shall have determined in good faith either that no adjustment is required or that an adjustment resulting in a decrease in the Exchange Price is required and, if so, the new Exchange Price as a result thereof and the basis upon which such adjustment is to be made and, in any such case, the date on which the adjustment shall take effect (and so that the adjustment shall be made and shall take effect accordingly); or

- (vi) any alteration to the Articles of Association made in connection with the matters described in this Condition 11 or which is supplemental or incidental to any of the foregoing (including any amendment made to enable or facilitate procedures relating to such matters and any amendment dealing with the rights and obligations of holders of Securities, including Ordinary Shares, dealt with under such procedures); or
 - (vii) any amendment of the Articles of Association (or other constitutional document) of the Parent Guarantor following or in connection with a Change of Control Event to ensure that any Bondholder exercising Conversion Rights where the Conversion Date falls on or after the occurrence of a Change of Control Event will receive, in whatever manner, the same consideration for the Ordinary Shares arising on exchange of the relevant Preference Shares in respect of such exercise as it would have received in respect of such Ordinary Shares had such Ordinary Shares been entitled to participate in the relevant Scheme of Arrangement or to have been submitted into, and accepted pursuant to, the relevant offer or tender (a “**Change of Control Conversion Right Amendment**”); or
 - (viii) a Permitted Issue (as defined in Condition 11(a) above);
- (c) except as part of or in connection with or pursuant to any employee, contractor, director or executive share or option or incentive scheme (whether for all employees, contractors, directors or executives or any one or more of them), procure that no Securities (whether issued by the Parent Guarantor or any Subsidiary of the Parent Guarantor or procured by the Parent Guarantor or any Subsidiary of the Parent Guarantor to be issued or issued by any other person pursuant to any arrangement with the Parent Guarantor or any Subsidiary of the Parent Guarantor) issued without rights to convert into, or exchange or subscribe for, Ordinary Shares shall subsequently be granted such rights exercisable at a consideration per Ordinary Share which is less than 95 per cent. of the Current Market Price per Ordinary Share at the relevant time for determination thereof pursuant to the relevant provisions of Condition 6(b) unless the same gives rise (or would, but for the provisions of Condition 6(f) relating to roundings and minimum adjustments or the carry forward of adjustments, give rise) to an adjustment to the Exchange Price and that at no time shall there be in issue Ordinary Shares of differing nominal values, save where such Ordinary Shares have the same economic rights;
- (d) not make any issue, grant or distribution or take or omit to take any other action if the effect thereof would be that, on the exercise of Conversion Rights, Ordinary Shares could not, under any applicable law then in effect, be legally issued as fully paid in exchange for the Preference Shares;
- (e) not reduce its issued share capital, share premium account, or any uncalled liability in respect thereof, or any non-distributable reserves, except:
- (i) pursuant to the terms of issue of the relevant share capital; or
 - (ii) by means of a purchase or redemption of share capital of the Parent Guarantor to the extent permitted by applicable law; or
 - (iii) where the reduction does not involve any distribution of assets to Shareholders; or
 - (iv) solely in relation to a change in the currency in which the nominal value of the Ordinary Shares is expressed; or
 - (v) to create distributable reserves; or
 - (vi) pursuant to a Scheme of Arrangement involving a reduction and cancellation of Ordinary Shares and the issue to Shareholders of an equal number of Ordinary Shares by way of capitalisation of profits or reserves; or

- (vii) as provided in Condition 11(a)(iii); or
- (viii) pursuant to a Newco Scheme; or
- (ix) by way of transfer to reserves as permitted under applicable law; or
- (x) where the reduction is permitted by applicable law and the Trustee is advised by an Independent Adviser, acting as an expert and in good faith, that in its opinion the interests of the Bondholders will not be materially prejudiced by such reduction; or
- (xi) where the reduction is permitted by applicable law and results (or, in the case of a reduction in connection with a Relevant Event, will result) in (or would, but for the provisions of Condition 6(f) relating to roundings or the carry forward of adjustments, result in) an adjustment to the Exchange Price or is (or, in the case of a reduction in connection with a Relevant Event, will be) otherwise taken into account for the purposes of determining whether such an adjustment should be made; or
- (xii) as permitted by Section 610(2) and (3) of the Companies Act; or
- (xiii) a reduction of its share premium account to facilitate the writing off of goodwill arising on consolidation which requires the confirmation of the High Court and which does not involve the return, either directly or indirectly, of an amount standing to the credit of the share premium account of the Parent Guarantor and in respect of which the Parent Guarantor shall have tendered to the High Court such undertaking as it may require prohibiting, so long as any of the Bonds remains outstanding, the distribution (except by way of capitalisation issue) of any reserve which may arise in the books of the Parent Guarantor as a result of such reduction;

provided that, without prejudice to the other provisions of these Conditions, the Parent Guarantor may exercise such rights as it may from time to time be entitled pursuant to applicable law to purchase, redeem or buy back its Ordinary Shares and any depositary or other receipts or certificates representing Ordinary Shares without the consent of Bondholders;

- (f) if any offer is made to all (or as nearly as may be practicable all) Shareholders (or all (or as nearly as may be practicable all) Shareholders other than the offeror and/or any associates (as defined in Section 988(1) of the Companies Act) of the offeror to acquire the whole or any part of the issued Ordinary Shares, or if any person proposes a scheme with regard to such acquisition (other than a Newco Scheme), give notice of such offer or scheme to the Trustee and the Bondholders at the same time as any notice thereof is sent to the Shareholders (or as soon as practicable thereafter) that details concerning such offer or scheme may be obtained from the specified offices of the Paying, Transfer and Conversion Agents and, where such an offer or scheme has been recommended by the board of directors of the Parent Guarantor, or where such an offer has become or been declared unconditional in all respects or such scheme has become effective, use all reasonable endeavours to procure that a like offer or scheme is extended to Bondholders and to the holders of any Ordinary Shares issued during the period of the offer or scheme arising out of the exercise of the Conversion Rights and the exchange of Preference Shares pursuant to these Conditions (which like offer or scheme to Bondholders shall entitle Bondholders to receive the same type and amount of consideration they would have received had they held the number of Ordinary Shares to which such Bondholders would be entitled assuming Bondholders were to exercise their Conversion Rights in the relevant Relevant Event Period);
- (g) in the event of a Newco Scheme, take (or shall procure that there is taken) all necessary action to ensure that (to the satisfaction of the Trustee) immediately after completion of the Scheme of Arrangement:

- (1) at the Parent Guarantor's option, either (a) Newco is substituted under the Bonds, the Trust Deed and the Deed Poll as principal obligor in place of the Issuer (with the Issuer and the Parent Guarantor providing a guarantee) subject to and as provided in the Trust Deed; or (b) Newco becomes a guarantor under the Bonds, the Trust Deed and the Deed Poll (jointly and severally with the Guarantors for the time being);
- (2) such amendments are made to these Conditions, the Trust Deed and the Deed Poll as are necessary, in the opinion of the Trustee, to ensure that the Bonds may be converted into or exchanged (whether by the exchange for preference shares or otherwise) for ordinary shares or units or the equivalent in Newco (or depositary or other receipts or certificates representing ordinary shares or units or the equivalent in Newco) *mutatis mutandis* in accordance with and subject to these Conditions with an Exchange Price (subject to adjustment as provided in these Conditions) economically equivalent to the Exchange Price immediately prior to the implementation of such amendments, as determined in good faith by an Independent Adviser;
- (3) the ordinary shares or units or equivalent of Newco (or depositary or other receipts or certificates representing ordinary shares or units or equivalents of Newco) are admitted to trading on a regulated, regularly operating, recognised stock exchange or securities market as determined by Newco; and
- (4) the Trust Deed and the Conditions provide at least the same or equivalent powers, protections, rights and benefits to the Trustee and the Bondholders following the implementation of such Newco Scheme as they provided to the Trustee and the Bondholders prior to the implementation of the Newco Scheme, *mutatis mutandis*,

and the Trustee shall (at the expense of the Parent Guarantor) (subject to the conditions in (1) to (4) above being satisfied) be obliged to concur in effecting such substitution or grant of such guarantee and in either case making any such amendments, provided that the Trustee shall not be obliged so to concur if, in the opinion of the Trustee, doing so would impose more onerous obligations upon it or expose it to any additional duties, responsibilities or liabilities or reduce or amend the protective provisions afforded to the Trustee in these Conditions, the Trust Deed, the Deed Poll or the Agency Agreement (including, for the avoidance of doubt, any supplemental trust deed or supplemental agency agreement) in any way.

- (h) use all reasonable endeavours to ensure that the Ordinary Shares issued upon exchange of the Preference Shares (if any) will, as soon as is practicable, be admitted to listing and to trading on the Relevant Stock Exchange and will be listed, quoted or dealt in, as soon as is practicable, on any other stock exchange or securities market on which the Ordinary Shares may then be listed or quoted or dealt in (but so that this undertaking shall be considered as not being breached as a result of a Relevant Event (whether or not recommended or approved by the board of directors of the Parent Guarantor) that causes or gives rise to, whether following the operation of any applicable compulsory acquisition provision or otherwise, (including at the request of the person or persons controlling the Parent Guarantor as a result of the Relevant Event) a de-listing of the Ordinary Shares);
- (i) use all reasonable endeavours to ensure, at its own cost, that its issued and outstanding Ordinary Shares are admitted to listing on a regulated, regularly operating, recognised stock exchange or securities market (but so that this undertaking shall be considered as not being breached as a result of a Relevant Event (whether or not recommended or approved by the board of directors of the Parent Guarantor) that causes or gives rise to, whether following the operation of any applicable compulsory acquisition provision or otherwise, (including at the request of the person or persons controlling the Parent Guarantor as a result of the Relevant Event) a de-listing of the Ordinary Shares);

- (j) at all times keep available for issue, free from pre-emptive or other preferential rights out of its authorised but unissued capital, sufficient authorised but unissued Ordinary Shares to enable the exercise of Conversion Rights in respect of all the Bonds (including any Further Bonds) then outstanding, and all rights of subscription and exchange for Ordinary Shares which are for the time being exercisable and/or have vested, to be satisfied in full at the then current Exchange Price, exercise price or, as the case may be, the subscription price;
- (k) procure that it shall not become domiciled or resident in or subject generally to the taxing authority of any jurisdiction (other than the United Kingdom) unless it would not thereafter be required pursuant to then current laws and regulations to withhold or deduct for or on account of any taxes, duties, assessments or governmental charges of whatever nature imposed or levied by or on behalf of such jurisdiction or any applicable sub-division thereof or therein having power to tax in respect of any payment on or in respect of the Bonds;
- (l) make or cause to be made an application for the New Bonds to be admitted to trading on the Open Market (*Freiverkehr*) of the Frankfurt Stock Exchange upon issue;

The Original Bonds were admitted to trading on the Open Market (Freiverkehr) of the Frankfurt Stock Exchange on 9 April 2021.

- (m) by no later than 23 June 2021 (i) publish a copy of these Conditions (including a legend regarding the intended target markets for the New Bonds) on its website and (ii) thereafter (and for so long as any of the Bonds remain outstanding) maintain the availability of these Conditions (as the same may be amended in accordance with their terms) on such website;
- (n) appoint an Independent Adviser as soon as reasonably practicable for the purpose of determining the Free Float if requested by the Trustee, acting at its sole discretion and without notice or acting at the direction of an Extraordinary Resolution of the Bondholders, or if requested in writing by the holders of at least one-tenth in principal amount of the Bonds then outstanding; and
- (o) use reasonable efforts (i) to ensure that the Subsidiary Guarantee of Helios Towers Congo Brazzaville SASU in an amount of not less than U.S.\$1 million becomes effective as soon as practicable following the Closing Date, including registration with the relevant tax authorities and applicable stamp duties paid thereon; (ii) to seek confirmation of “no-objection” from the Bank of Tanzania in relation to the Subsidiary Guarantee of HTT Infracore Limited as soon as reasonably practicable following the Closing Date; and (iii) to ensure that if and to the extent that any proceeds of the Bonds are on-loaned by the Issuer or another member of the Group to any member of the Group (as borrower) in Tanzania, such on-loaned amount is legally able to be repatriated from Tanzania to the lender under the related Tanzanian Intercompany Loan.

Whilst any Bond remains outstanding, the Issuer will, and the Parent Guarantor will procure that the Issuer will, save with the approval of an Extraordinary Resolution or with the prior written approval of the Trustee:

- (p) comply with the obligations assumed by it under the Constitution of the Issuer and not make any amendment to the Constitution of the Issuer which would vary, abrogate or modify the rights appertaining to the Preference Shares in a manner which might reasonably be expected to be prejudicial to the holders of the Preference Shares or to the Bondholders (provided that the creation or issue of any class of share capital ranking junior to or *pari passu* with the Preference Shares as regards rights to dividends and to payment of the paid-up value thereof on a return of capital or otherwise shall be deemed not to be a variation, abrogation or modification of the rights appertaining to the Preference Shares);

- (q) not issue any other share capital with rights which are more favourable than the rights attaching to the Preference Shares in respect of dividends or payment of the Paid-up Value thereof or on a return of capital or otherwise;
- (r) not cause the Paid-up Value of the Preference Shares to be altered (whether by consolidation or subdivision of the Preference Shares or otherwise);
- (s) at all times, keep available for issue, free from pre-emptive rights out of its authorised but unissued capital, such number of Preference Shares as would enable all the unexercised Conversion Rights and any other rights of conversion into, subscription for and exchange into Preference Shares to be satisfied in full; and
- (t) except with the prior written consent of the Trustee pursuant to the Trust Deed, not alter those provisions of the Trust Deed which are expressed to be binding only as between the Issuer and the Parent Guarantor and not directly enforceable by Bondholders.

The Issuer has undertaken in the Trust Deed to deliver to the Trustee annually and otherwise on request by the Trustee a certificate signed by two Authorised Signatories of the Issuer as to there not having occurred an Event of Default, Potential Event of Default or breach of the Trust Deed since the date of the last such certificate (or, in the case of the first such certificate, the date of the Trust Deed) or if such event or breach has occurred as to the details of such event or breach and the Trustee will be entitled to rely (without further enquiry and without liability to any person) on such certificate. The Trustee shall not be obliged to independently monitor compliance by the Issuer or the Parent Guarantor with the undertakings set forth in this Condition 11 nor be liable to any person for not so doing.

12 Prescription

Claims against the Issuer, the Parent Guarantor and the other Guarantors for payment in respect of the Bonds shall be prescribed and become void unless made within 10 years (in the case of principal or any other amount (other than interest)) or five years (in the case of interest) from the appropriate Relevant Date in respect of such payment.

Claims in respect of any other obligation in respect of the Bonds, including delivery of Preference Shares or Ordinary Shares, shall be prescribed and become void unless made within 10 years following the due date for performance of the relevant obligations.

13 Replacement of Bonds

If any Bond is lost, stolen, mutilated, defaced or destroyed, it may be replaced at the specified office of any Paying, Transfer and Conversion Agent subject to all applicable laws and stock exchange requirements, upon payment by the claimant of the expenses incurred in connection with such replacement and on such terms as to evidence, indemnity and otherwise as the Issuer and the Parent Guarantor may reasonably require. Mutilated or defaced Bonds must be surrendered before replacements will be issued.

14 Meetings of Bondholders, Modification and Waiver, Substitution

(a) Meetings of Bondholders

The Trust Deed contains provisions for convening meetings of Bondholders to consider matters affecting their interests, including the sanctioning by Extraordinary Resolution of a modification of any of these Conditions or any provisions of the Trust Deed, the Deed Poll or the Constitution of the Issuer (in the case of the Constitution of the Issuer, which would vary, abrogate or modify the rights appertaining to

the Preference Shares in a manner that would be prejudicial to the holders of the Bonds or Preference Shares). Such a meeting may be convened by the Issuer, the Parent Guarantor or the Trustee and shall be convened by the Issuer if requested in writing by Bondholders holding not less than 10 per cent. in principal amount of the Bonds for the time being outstanding.

The quorum for any meeting convened to consider an Extraordinary Resolution will be one or more persons holding or representing more than one-half in principal amount of the Bonds for the time being outstanding, or at any adjourned meeting one or more persons being or representing Bondholders whatever the principal amount of the Bonds so held or represented, unless the business of such meeting includes consideration of proposals, *inter alia*, (i) to change the Final Maturity Date, the First Call Date (other than deferring the First Call Date) or any dates for payment of interest or any other amount in respect of the Bonds, (ii) to modify the circumstances in which the Issuer or Bondholders are entitled to redeem the Bonds pursuant to Condition 7(b), (c) or (e) (other than removing the right of the Issuer to redeem the Bonds pursuant to Condition 7(b) or (c)), (iii) to reduce or cancel the principal amount of, or interest on, the Bonds or to reduce the amount payable on redemption of the Bonds or to reduce the obligations of any of the Guarantors under the Bonds and the Trust Deed other than in accordance with the Conditions, (iv) to modify the basis for calculating the interest or any other amount payable in respect of the Bonds, (v) to modify the provisions relating to, or cancel, the Conversion Rights or the rights of Bondholders to receive Ordinary Shares in exchange for Preference Shares issued on exercise of Conversion Rights pursuant to these Conditions (other than pursuant to or as a result of any amendments to these Conditions, the Trust Deed, the Deed Poll or the Constitution of the Issuer made pursuant to and in accordance with the provisions of Condition 6(n) in order to effect a Conversion Right Transfer or Condition 11(g) following or as part of a Newco Scheme (“**Newco Scheme Modification**”), and other than a reduction to the Exchange Price or an increase in the number of Preference Shares or Ordinary Shares to be issued to Bondholders on exercise of Conversion Rights), (vi) to increase the Exchange Price (other than in accordance with these Conditions or pursuant to a Newco Scheme Modification) or to reduce the number of Preference Shares or Ordinary Shares to be issued to Bondholders on exercise of Conversion Rights, (vii) to change the currency of the denomination of the Bonds or of any payment in respect of the Bonds, (viii) to change the governing law of the Bonds, the Trust Deed, the Deed Poll or the Agency Agreement (other than in the case of a substitution of the Issuer or Parent Guarantor (or any previous substitute or substitutes) under Condition 14(c)), (ix) to modify the Constitution of the Issuer so as to vary, abrogate or modify the rights appertaining to the Preference Shares in a manner that would be prejudicial to the holders of the Bonds or Preference Shares; or (x) to modify the provisions concerning the quorum required at any meeting of Bondholders or the majority required to pass an Extraordinary Resolution, in which case the necessary quorum will be one or more persons holding or representing not less than two-thirds, or at any adjourned meeting not less than one-third, in principal amount of the Bonds for the time being outstanding. Any Extraordinary Resolution duly passed by the Bondholders shall be binding on all Bondholders (whether or not they were present at the meeting at which such resolution was passed and whether or not they voted on such resolution).

The Trust Deed provides that (i) a resolution in writing signed by or on behalf of the holders of not less than 75 per cent. of the aggregate principal amount of the Bonds outstanding (which may be contained in one document or several documents in the same form, each signed by or on behalf of one or more Bondholders) or (ii) a consent given by way of electronic consent through the relevant clearing system(s) by or on behalf of the holders of not less than 75 per cent. of the aggregate principal amount of the Bonds outstanding, shall, in any such case, be effective as an Extraordinary Resolution passed at a meeting of Bondholders duly convened and held.

No consent or approval of Bondholders shall be required in connection with any Conversion Right Transfer effected in accordance with Condition 6(n) or any Newco Scheme Modification.

(b) *Modification and Waiver*

The Trustee may agree, without the consent of the Bondholders, to (i) any modification of any of the provisions of the Trust Deed, any trust deed supplemental to the Trust Deed, the Congo B Deed of Guarantee, the Agency Agreement, any agreement supplemental to the Agency Agreement, the Bonds or these Conditions, the Deed Poll or the Constitution of the Issuer which in the Trustee's opinion is of a formal, minor or technical nature or is made to correct a manifest error or to comply with mandatory provisions of law, and (ii) any other modification to the Trust Deed, any trust deed supplemental to the Trust Deed, the Congo B Deed of Guarantee, the Agency Agreement, any agreement supplemental to the Agency Agreement, the Bonds or these Conditions, the Deed Poll or the Constitution of the Issuer (except as mentioned in the Trust Deed), and any waiver or authorisation of any breach or proposed breach of any of the provisions of the Trust Deed, any trust deed supplemental to the Trust Deed, the Congo B Deed of Guarantee, the Agency Agreement, any agreement supplemental to the Agency Agreement, the Bonds or these Conditions, the Deed Poll or the Constitution of the Issuer which is, in the opinion of the Trustee, not materially prejudicial to the interests of the Bondholders.

The Trustee may, without the consent of the Bondholders, determine that any Event of Default or a Potential Event of Default should not be treated as such, provided that in the opinion of the Trustee, the interests of Bondholders will not be materially prejudiced thereby.

Any such modification, authorisation, waiver or determination shall be binding on the Bondholders and, if the Trustee so requires, shall be notified to Bondholders as soon as practicable.

(c) *Substitution*

The Trustee shall (subject as provided in Condition 11(g)), without the consent of the Bondholders, agree to any substitution as provided in, and for the purposes of, Condition 11(g) in connection with a Newco Scheme.

The Trustee shall (subject as provided in Condition 6(n)), without the consent of the Bondholders, agree to any substitution as provided in, and for the purposes of, Condition 6(n) in connection with a Successor in Business.

In addition, the Trustee may agree, without the consent of the Bondholders, to the substitution in place of the Issuer (or any previous substitute or substitutes under this Condition) as the principal debtor under the Bonds and the Trust Deed of the Parent Guarantor or any other Subsidiary of the Parent Guarantor, subject to (a) the Bonds being unconditionally and irrevocably guaranteed by the Parent Guarantor (unless the Parent Guarantor is the principal debtor) and the obligations under the Deed Poll applying *mutatis mutandis* to such preference shares in the capital of the substituted company, (b) the Bonds continuing to be convertible as provided in these Conditions into preference shares in the capital of the substituted company with like rights, *mutatis mutandis*, to the Preference Shares and to such preference shares being immediately exchangeable for Ordinary Shares *mutatis mutandis* as provided in the Constitution of the Issuer, with such amendments as the Trustee shall consider appropriate and (c) the obligations of the Subsidiary Guarantors under the Trust Deed (and the Congo B Deed of Guarantee) applying *mutatis mutandis* to, and continuing to be legally enforceable in respect of, the Bonds, provided that (x) the Trustee is satisfied that the interests of the Bondholders will not or are not likely to be materially prejudiced by the substitution, and (y) certain other conditions set out in the Trust Deed are complied with. In the case of such a substitution the Trustee may agree, without the consent of the Bondholders, to a change of the law governing the Bonds and/or the Trust Deed and/or the Congo B Deed of Guarantee) provided that in the opinion of the Trustee such change would not or is not likely to

be materially prejudicial to the interests of the Bondholders. Any such substitution shall be binding on the Bondholders and shall be notified to Bondholders as soon as practicable.

(d) *Entitlement of the Trustee*

In connection with the exercise of its functions (including but not limited to those referred to in this Condition) the Trustee shall have regard to the interests of the Bondholders as a class but shall not have regard to any interests arising from circumstances particular to individual Bondholders (whatever their number) and, in particular but without limitation, shall not have regard to the consequences of the exercise of its trusts, powers or discretions for individual Bondholders resulting from their being for any purpose domiciled or resident in, or otherwise connected with, or subject to the jurisdiction of, any particular territory, and the Trustee shall not be entitled to require, nor shall any Bondholder be entitled to claim, from the Issuer or the Parent Guarantor or any other person any indemnification or payment in respect of any tax consequence of any such exercise upon individual Bondholders, except to the extent provided for in these Conditions or the Trust Deed.

15 Enforcement

The Trustee may at any time, at its discretion and without notice, take such proceedings, actions or steps against the Issuer and/or the Guarantors as it may think fit to enforce the provisions of the Trust Deed, the Congo B Deed of Guarantee, the Deed Poll the Agency Agreement and the Bonds, but it shall not be bound to take any such proceedings, actions or steps unless (i) it shall have been so directed by an Extraordinary Resolution of the Bondholders or so requested in writing by the holders of at least 25 per cent. in principal amount of the Bonds then outstanding, and (ii) it shall have been indemnified and/or secured and/or prefunded to its satisfaction. Notwithstanding the above:

- (i) the Trustee may refrain from taking any proceedings, actions or steps in any jurisdiction if the taking of such action in that jurisdiction would, in its opinion based upon legal advice in the relevant jurisdiction, be contrary to any law of that jurisdiction; and
- (ii) the Trustee may refrain from taking any proceedings, actions or steps in any jurisdiction if in its opinion based upon legal advice in the relevant jurisdiction it would or may render it liable to any person in that jurisdiction or, it would or may not have the power to do the relevant thing in that jurisdiction by virtue of any applicable law in that jurisdiction or if it is determined by any court or other competent authority in that jurisdiction that it does not have such power.

No Bondholder shall be entitled to (i) take any proceedings, actions or steps against the Issuer and/or the Guarantors to enforce the performance of any of the provisions of the Trust Deed, the Congo B Deed of Guarantee, the Agency Agreement or the Bonds or (ii) take any other proceedings, actions or steps (including lodging an appeal in any proceedings) in respect of or concerning the Issuer, in each case unless the Trustee, having become bound so to take any such proceedings, actions or fails so to do within a reasonable period and the failure shall be continuing.

16 The Trustee

The Trust Deed contains provisions for the indemnification of the Trustee and for its relief from responsibility, including:

- (i) provisions relieving it from taking any proceedings, actions or steps unless indemnified and/or secured and/or prefunded to its satisfaction; and
- (ii) provisions limiting or excluding its liability in certain circumstances.

The Trustee is entitled to enter into business transactions with the Issuer, the Guarantors and any entity related to the Issuer or the Guarantors without accounting for any profit.

The Trust Deed provides that, when determining whether an indemnity or any security or pre-funding is satisfactory to it, the Trustee shall be entitled (i) to evaluate its risk in any given circumstance by considering the worst-case scenario and (ii) to require that any indemnity or security or prefunding given to it by the Bondholders or any of them be given on a joint and several basis and be supported by evidence satisfactory to it as to the financial standing and creditworthiness of each counterparty and/or as to the value of the security and an opinion as to the capacity, power and authority of each counterparty and/or the validity and effectiveness of the security.

The Trustee may act and rely without liability to Bondholders and without further investigation on a report, confirmation, certificate, opinion or any advice of any accountants, financial advisers, financial institution, an Independent Adviser or other expert, whether or not addressed to it and whether their liability in relation thereto is limited (by its terms or by any engagement letter relating thereto entered into by the Trustee or any other person or in any other manner) by reference to a monetary cap, methodology or otherwise. The Trustee may accept and shall be entitled to act and rely on any such report, confirmation, certificate, opinion or advice and such report, confirmation, certificate, opinion or advice shall be binding on the Issuer, the Parent Guarantor, the Trustee and the Bondholders.

17 Notices

All notices required to be given to Bondholders pursuant to the Conditions will (unless otherwise provided in these Conditions) be given by publication through the electronic communication system of Bloomberg. The Issuer shall also ensure that all notices are duly published (if such publication is required) in a manner which complies with the rules and regulations of any stock exchange or other relevant authority on which the Bonds are for the time being listed and/or admitted to trading. Any such notice shall be deemed to have been given on the date of such publication or if required to be published in more than one manner or at different times, then such notice shall be deemed to have been given on the date of the publication in each required manner and time. If publication as provided above is not practicable, notice will be given in such other manner, and shall be deemed to be given on such date, as the Trustee may approve.

The Issuer shall send a copy of all notices given by it to Bondholders (or a Bondholder) or the Trustee pursuant to these Conditions promptly thereafter to the Principal Paying, Transfer and Conversion Agent and the Calculation Agent.

For so long as the Bonds are represented by a Global Bond registered in the name of, and held by a nominee on behalf of, a common depositary for Euroclear or Clearstream, Luxembourg notices required to be given to Bondholders pursuant to the Conditions may instead be given by the delivery of the relevant notice to Euroclear and/or Clearstream, Luxembourg as the case may be. Any such notice shall be deemed to have been given on the day on which such notice is delivered to Euroclear and/or Clearstream, Luxembourg.

18 Further Issues

The Issuer and the Parent Guarantor may from time to time without the consent of the Bondholders create and issue further notes, bonds or debentures either having the same terms and conditions in all respects as the outstanding notes, bonds or debentures of any series (including the Bonds) or in all respects except for the first payment of interest on them and the first date on which Conversion Rights may be exercised and so that such further issue shall be consolidated and form a single series with the outstanding notes, bonds or debentures of any series (including the Bonds) or upon such terms as to interest, conversion, premium, redemption and otherwise as the Issuer and the Parent Guarantor may determine at the time of their issue. Any further notes,

bonds or debentures forming a single series with the outstanding notes, bonds or debentures of any series (including the Bonds) constituted by the Trust Deed or any deed supplemental to it shall be constituted by a deed supplemental to the Trust Deed (and, where applicable, the Congo B Deed of Guarantee).

19 Contracts (Rights of Third Parties) Act 1999

No person shall have any right to enforce any term or condition of the Bonds under the Contracts (Rights of Third Parties) Act 1999.

20 Governing Law

The Trust Deed, the Congo B Deed of Guarantee, the Deed Poll, the Agency Agreement and the Bonds and any non-contractual obligations arising out of or in connection with them are governed by, and shall be construed in accordance with, English law.

21 Jurisdiction

The courts of England are to have jurisdiction to settle any disputes which may arise out of or in connection with the Trust Deed, the Congo B Deed of Guarantee or the Bonds (and any non-contractual obligations arising out of or in connection with them) and accordingly any legal action or proceedings arising out of or in connection with the Trust Deed, the Congo B Deed of Guarantee or the Bonds (“**Proceedings**”) may be brought in such courts. The Issuer and the Guarantors have in the Trust Deed irrevocably submitted to the jurisdiction of such courts and have waived any objection to Proceedings in such courts whether on the ground of venue or on the ground that the Proceedings have been brought in an inconvenient forum. This submission is made for the benefit of the Trustee and each of the Bondholders and shall not limit the right of any of them to take Proceedings in any other court of competent jurisdiction nor shall the taking of Proceedings in one or more jurisdictions preclude the taking of Proceedings in any other jurisdiction (whether concurrently or not).

22 Agent for Service of Process

The Issuer and each Initial Subsidiary Guarantor has, and any other Subsidiary of the Parent Guarantor which is not incorporated in United Kingdom and which provides a Guarantee in accordance with Condition 1(D) will, irrevocably appoint the Parent Guarantor as its agent in England to receive service of process in any Proceedings in England. Nothing herein or in the Trust Deed or the Congo B Deed of Guarantee shall affect the right to serve process in any other manner permitted by law.
